LOCAL PUBLIC SERVICES AGREEMENT - UPDATE ON TARGETS

<u>Target 1</u>: To promote the physical, emotional, social and intellectual development of young children so they flourish at home and at school.

Indicators by which performance will be measured

- i. take-up of early years education by 3 year olds
- ii. the number of lone parents on income support across Kent
- iii. In 3 District Council areas with high levels of deprivation (Dover, Gravesham and Swale) advance the development of young children by the age of 5 by 2 months, as measured by the following:

 - Language Test: (BAS Naming Vocabulary and Verbal Comprehension).

- iii. the number of 16-18 year olds not in education, employment or training (NEET) with no increase in the number of 16-18 year olds categorised as unknown.

A "reassurance measure" is required and the following is proposed:

In 2003, our baseline year, 90.9% of our learners achieved Level 1 qualifications and 55.6% of our learners achieved Level 2 qualifications. We anticipate that the percentage of earners achieving overall qualifications at levels 1 & 2 will not fall below this level

Should there be a decline in performance by 2008, for every 1% decline in the percentage of learners below the Level 1 2003 figure, Kent will lose 1% of its performance reward grant for that sub-indicator. For every 1% decline in the percentage of learners below the Level 2 2003 figure, Kent will lose 1% of its performance reward grant for that sub-indicator.

i. reducing by 10% the number of care managed clients in a permanent residential/ nursing placement. (Including preserved rights clients but excluding section 28(a) clients)

And

- ii. increasing by 9% the number of supporting people service users³*, who have successfully completed a planned move from a short-term service into independence. This information is broken down to reflect a balance against indicator i.
 - **NB.** The information that relates to * does not necessarily imply that the individuals in receipt of a service have been moved into a short-term service directly from a residential / nursing placement. It does however mean that by being in receipt of the service it is preventing an individual from having to move into a residential / nursing placement
