- Ethos – ‘Forces Friendly’ Authority
- Page 2 Leading by example – KMCMPB ‘exemplar’
- Signed 2011, re-signed with Medway 2017
- Kent & Medway Civilian-Military Partnership Board awarded **Gold (2018)**

Only UK CMPB with a Unitary

The Armed Forces Act 2021

The Armed Forces Covenant was enshrined in law in November 2022 – after Statutory Guidelines passed by Parliament

Requires all **Public Bodies** including LAs, CCGs, NHS Trusts and Schools to show 'due regard' and **consistency** in the provision of following services:-

- * Education
- * Healthcare
- * Housing and Homelessness

**Ensures no one disadvantaged
because of their service to the Nation**

**Councils will need to consciously consider the Armed
Forces Community when developing policy and decisions**


