TERMS OF REFERENCE

The Local Engagement Forum (LEF) will consider matters relating to:

- a. Provision and performance for services provided on a statutory basis by all Councils;
- b. Services provided by other public bodies, including the Police, Fire and Rescue and Health Authorities where these impact upon local communities;
- c. Input to, and outputs from, the Local Strategic Partnership;
- d. Input to, and output from both Borough and County scrutiny panels;
- e. The LEF will also be a forum for consultation between the Councils and with the public on policies, plans and strategies;
- f. The LEF may also review performance of services and service providers and, as a consequence, make recommendations in an advisory capacity to the Executive Bodies of the respective councils.

In the half hour before the start of the meeting, LEF Members and Officers will be available to discuss informally, either collectively or on a one-to-one basis, any matters that may be raised by the public present.
