STANDING ADVISORY COUNCIL ON RELIGIOUS EDUCATION (KENT)

MINUTES of a meeting of the Standing Advisory Council on Religious Education (SACRE) held in the Council Chamber, Sessions House, County Hall, Maidstone on Wednesday, 5 March 2014.

PRESENT: Mr S C Manion (Chairman), Mrs N Younosi (Vice-Chairman), Mr J Elenor, Mrs P Fairchild, Ms K Burke, Rabbi C Cohen, Mrs V Corbyn, Mrs J Grant, Miss T Kelvie, Miss S Lacon, Mr T A Maddison, Miss S Malone. Mr M Papadopoullos, Mr S Platnauer. Mrs T Martin. Mr M J Northey, Mrs V Thornewell, Miss R Walters and Miss J Webb

22. Membership

To note the resignation of Mrs M McDowall -Group 1 Roman Catholic and Miss S Shaw – Group 2 Canterbury Diocese

23. Minutes

The Minutes of the meeting held on 19 November 2013 were approved as a correct record and signed by the Chairman subject to the following addition to Minute 12.2 training specifically being recorded as an Early Years Foundation Stage Course.

24. Budget Summary

Mr Foster reported the achieved budget spend had been more realistic for the current financial year at 81% and it was intended the trend would continue. He reminded members to submit all expense claims promptly.

25. Youth SACRE - October 2014 - Date tbc

- 25.1 The date of the second Youth SACRE meeting was announced as Tuesday 18 November 2014 in the Council Chamber, County Hall, Maidstone.
- 25.2 Mr Foster advised this was Interfaith week.
- 25.3 Mrs Grant would take the lead, supported by Mrs Younosi and Mrs Corbyn would secure Lat Blaylock from RE Today, as guest Speaker.
- 25.4 Members extended their thanks to Mr Tyson for leading the very successful inaugural meeting.

26. SACRE Development Plan

26.1 Mrs Martin advised she had attempted to produce a Plan based on members instructions.

26.2 Page 11

There was much debate about the difficulty of accessing the Agreed Syllabus and SACRE documents which were previously online, but had been deleted from kenttrustweb. Mr Foster requested that any members with electronic versions of supporting resources forward them to him as he was having issues locating some documents.

- 26.3 Mr Foster confirmed that Mr Gough (Cabinet member) was fully aware and Mr Northey agreed to maintain the pressure to get the situation rectified. Mrs Martin asked for permission to add the SACRE documents to both the Rochester and Canterbury Diocesan websites, plus CCCU and this was unanimously agreed.
- 26.4 Mr Gillespie reported he had 230 students all wanting to access the Syllabus and Mr Foster suggested the KELSI web address: http://www.kelsi.org.uk/curriculum_and_pupil_learning/curriculum/re.aspx
- 26.5 Further debate ensued about the best frequency for sampling of schools. Mrs Corbyn and Mrs Martin offered to establish the details of VC schools in their patch, to contribute to a written report detailing whether specific schools were engaging or not.
- 26.6 Mr Foster confirmed the Annual Report contained his findings and he would not want to "name and shame".
- 26.7 Mr Foster requested Members email him suggested questions to be included in the survey before the next meeting. Mrs Walters suggested the following questions be included:-
 - Does your school have a named RE Co-ordinator?
 - Does the RE Co-ordinator have a regular slot for RE issues in Staff Meetings and/or on the CPD calendar?
 - Does your school have a copy of the latest Kent Agreed Syllabus, if so is a paper copy or online?
 - Are staff aware of the location of the Agreed Syllabus?
 - How is long term planning for RE created?
 - Do staff work from a common lesson plan for RE?
 - Does RE have dedicated curriculum time? In what format for Early Years/KS1 and KS2?
 - Do all classroom teachers teach RE? If not who else staffs RE?
 - How is RE assessed and recorded as evidence of pupil achievement?
 - Does RE have a resource budget?
 - Mrs Walters offered to provide a presentation to Members about how she deals with SMSC/Collective Worship in teacher training.
- 26.8 The Chairman suggested Mr Foster undertake 1 survey per year, from 3 or 4 areas, under his own time frame and record his findings in the Annual Report.

- 26.9 Mr Maddison suggested all County members be furnished with a copy of the Survey and requested to consult any Governing bodies they were associated with.
- 26.10 Mr Foster agreed to give verbal interim feedback in November and complete feedback in March 2015.

26.11 Page 12

Mr Foster was concerned about how to market high quality CPD in a non responsive market. The free Diocesan CPD event had faired better with 63 attendees. Mrs Corbyn was hopeful it may be possible to offer a couple of future events -one on RE, one on CW, if costs were cut to the bone, there was no doubt teachers were more likely to attend if events were free.

- 26.12 Members expressed a wish to financially support CPD, budget permitting.
- 26.13 Mr Gough had suggested SACRE could make a strong business case for requesting additional funding and Mr Foster advised he could bid for funds in order to offer at least one free event across the County in the coming year.
- 26.14 Mr Foster had attempted to raise SACRE's profile in a number of ways, including submitting information to the Governor magazine, an information sheet to all Academies, engaging the County on publishing the syllabus and support materials online and sharing with County members and Directors of ELS.
- 26.15 Mr Gough had agreed to attend the November 2014 SACRE meeting.

27. Patterns of Attendance

- 27.1 Members noted the current position and were advised work was continuing in regard to filling any vacancies.
- 27.2 It was noted co-opted members were no longer recorded, as being Non-voting members their attendance did not contribute towards the meeting being shown to be quorate.

28. Overview of National and Local Developments

- 28.1 Mr Foster reported on the following:-
 - BBC Radio Kent Interview 10.1.14 Future of RE in Kent schools. Issues raised included Academies programme, changes to GCSE & A Level exams, introduction of new National Curriculum & RE's position, plight of lack of RE specialist teachers in schools.
 - Meeting with Roger Gough KCC Cabinet Member for Education 16.1.14.
 - Present Roger Gough, Simon Webb (senior School Improvement Adviser) for Sue Rogers, Steve Manion – Chair SACRE, Nicky Younosi – Vice Chair, Michael Northey, Richard Tyson, Allan Foster.

- Agenda items RE in Kent schools, Future of Youth SACRE & ELS involvement, SACRE's interaction with Education Cabinet Committee
- AF updated on recent SACRE Annual Report, Ofsted report and RE Review & issues raised and how these are concerns in Kent. Also raised concerns about removal of Syllabus and support materials from Kenttrustweb.
- ELS to support with HT briefings to promote responsibilities for RE AF to provide briefing paper to SW
- Survey via Governors if required AF to speak to Linda Lissimore
- Youth SACRE discussion re annual event in autumn NY suggested that KCC might provide additional funding for this – RT rejected this idea on grounds that initial event had not required funding. AF suggested that a business case for additional funding could be made if appropriate.
- RG indicated he would like to be kept involved with SACRE developments –
 perhaps by attending Briefing meetings, or a future meeting invited to
 November meeting. Annual report to be agenda item at future Education
 Cabinet Committee meeting.
- Following this meeting suggestion that RG be asked to write to Michael Gove raising Kent's concerns. Letter prepared and sent to SM & NY to send to RG on 8.2.14
- Mr Maddison commented he would have liked to have had sight of the letter in order to secure All party support.

 Original web pages removed and documents deleted. Some confusion within ELS over documents on SACRE pages of Kent.gov.uk. Replacement copies of Syllabus, non-statutory Guidance, Shaping the Spirit, Gathering Together, Sikhism Transition Unit booklet, & DCFS Guidance to Schools. Currently only Non-statutory Guidance & DCFS on KELSI. Syllabus (statutory doc) linked to Kent.gov.uk. Support documents for Sikhism, SMSC & CAW will need updating and removal of ASK logos and links. Discussions are ongoing.
- CPD event for EYFS report to follow
- CPD event for Primary non-specialist teachers 24.2.14 10 attended, led by Liz Pope. V Good feedback. Two other events cancelled due to low numbers.
- Westhill Awards 2014 theme Education into Diversity generating compelling learning experiences in RE for young people relevant to today's context. Applications closed in March and Members were requested to email Mr Foster any theme suggestions for a Kent bid.
- Very recent invitation via NASACRE for teacher representatives to join the new Expert Advisory Group (EAG) for RE. Similar groups have been set up to implement the new National Curriculum. The RE EAG will have the same kind

of task, building on the new national framework from the RE Review. Closing date for applications is 11th March 2014.

- Mrs Corbyn requested this be advertised on the Kent Bulletin. Mr Northey agreed to speak to Mrs Rogers to achieve urgent action, in the hope that a Kent teacher could have input into Mr Gove's committee.
- Ms Burke voiced her opinion that the teaching of RE in schools was in a general mess and members tried to convince her a good channel for her anxieties would be to join the advisory Group.

29. NASACRE AGM-22 May 2014 Westminster

The clerk would register Mr Manion and Mrs Younosi for attendance at the AGM.

30. The REC Review of RE in England

- 30.1 Mr Foster had provided the link to the REC launch of the RE curriculum review document; http://resubjectreview.recouncil.org.uk/re-review-report
 He considered the recommendations a good fit with the Agreed syllabus. It was likely the topic would be discussed at the forth coming NASACRE AGM and there was a briefing paper on their website which he urged members to read.
- 30.2 The REC Review currently had no status, it was the period before decisions were made and members should acquaint themselves with the issues. Mr Maddison commented it was helpful to note the aims on page 15 and felt it was an opportunity to embrace commonalities and good practice.
- 30.3 Mr Foster stated the review should be considered in the light of the national picture and any future review of the Kent syllabus. Mrs Walters concurred with this view. Mrs Corbyn advised caution, as she was aware that there were ongoing discussions.

Rising to the Challenge

Keynote Speaker: Stephen Lloyd, MP,

Chair do All Party Parliamentary Group (APPG) on Religious Education.

Main points of talk:

- APPG, why started? In today's "global" world there is a strong need to teach children the facts of world religions by trained teachers.
- SL (Stephen Lloyd) stressed that all concerned with the teaching of RE strongly believe in the above.
- Need to recognise that teaching world religions in schools is stronger now than ever before.
- RE teachers are "profoundly" professional and committed to teaching this subject but feel, unfortunately, under valued even though RE is a most important subject.
- Now is the right time, before a General Election, to focus on RE teaching and it's place in the curriculum, now is the time to lobby.
- SACREs need to appreciate the commitment and determination of RE teachers; APPG fully supports RE teaching and training.
- Need to ensure children understand world religions. RE teaching is around truth, freedom, understanding, history and living in harmony.
- History shows that inaccurate understanding of religion/s leads to trouble and strife,.

Questions/ Answers

- 1. How to deal with media negativity and inaccuracy? APPG and NASACRE need to work together to deal with this.
- 2. What about schools (e.g. free schools) not teaching RE? APPG looking into this issue. All schools are funded to teach RE. If this is not happening raise awareness of this with local MP..All political parties need to put teaching RE on their manifestos and SACREs need to help APPG do this. Use the General Election for this.
- 3. Religious literacy is needed not just to teach facts but to teach how to handle facts. It is learning about and learning from. APPG agrees RE is more than just teaching facts.
- 4. LA support. Budgets are being slashed and some SACREs are without admin support. Will add this to the APPG agenda.
- 5. The future of SACREs? Confident APPG is winning the battle in Westminster. It is going to be difficult for SACREs for the next couple of years, but change is coming.

- 6. There is a concern regarding properly train RE teachers and RE teacher CPD and professional progression; a concern that RE teachers are leaving the profession or are moving away from RE as a subject. APPG and SACREs need to help the DfE to draw up a criteria and protocol to support RE teachers. Pay related performance management is here to stay for a few more years. A protocol is needed to help head teachers to evaluate RE.
- 7. Area of concern: voice of the child needs to be part of the planning and process, how do we measure success? An important issue. Success? How peoples' attitudes have changed over the last 30 years. There is a need to keep communication outlets open.
- 8. How can we work together to continue the good work? Keep up the pressure on DfE, Westminster and lobby different parties. Need to create a scheme to publicly reward outstanding teachers and students. Work together with REC, APPG and local SACRE.
- 9. What if the LEA becomes a commissioning only LEA? Get LA Councils to recognise value of SACREs and preserve SACREs, involve local MPs, encourage local MP to talk to SL. Need to raise this issue with Education Secretary and arrange a debate regarding RE and macadamias and free schools.

Business Meeting:

- invite local MP to talk on why RE is important
- performance related pay is a new issue and not a welcome addition. If a teacher teaches just one RE lesson a week DfE counts it as a teacher in post and the result is that it shows no RE teacher shortage.- the problem of RE teachers' CPD has not gone away. NASACRE aware of this and is working at national level to find a solution.
- NASACRE has put in a bid to fund the analysing of SACRE annual reports. Annual reports are very welcome.
- All academies and free schools also have funding to teach RE, if not doing so then SACRE should inform DfE.
- Chairman should attend head teachers meetings to discuss concerns and issues.
