# Andrew Ireland – Corporate Director of Social Care, Health and Wellbeing, Kent County Council

#### **Biography**

Andrew qualified as a Social Worker in 1980 and worked for the Borough of Croydon and Lewisham before joining Kent County Council in 1987.

Andrew worked for Kent County Council for 18 years in a number of roles covering the whole spectrum of Social Services work. In 2002, he was appointed Area Director for Social Services in West Kent and in 2005 was seconded to Swindon Borough Council as Acting Director of Social Services, raising standards there from failing to "one star" rating.

Andrew was appointed to Havering as Group Director for Children's Services in January 2006. From March 2008, he also took on the role of Director of Adult Social Services in Havering and in June 2008 he became Group Director, Social Care and Learning.

Andrew took up the role of the Corporate Director for Families and Social Care for Kent County Council on 1 November 2011. He also holds the statutory functions of Director of Adults Social Services (DASS) and Director of Children's Services (DCS) for the council, with responsibility for the support and social care needs of over 2,000 children and 20,000 adults who live in Kent.

Andrew is active in the national associations for DASS and for DCS. He is joint chair of the ADASS/ADCS Joint Committee and a member of the ADASS Executive Council.

#### **Kent County Council's IRO service**

The Kent Independent Reviewing Officer (IRO) service is part of Kent County Council's Social Care, Health and Wellbeing Directorate, sitting within the Children's Safeguarding Unit. The role of the County IRO Manager is undertaken by the Head of Quality Assurance.

#### There are 2 IRO teams:

- The East and South Kent Area Team (1 Team Manager and 12 IROs)
- The North and West Kent Area Team and Unaccompanied Asylum Seeker Team (1 Team Manager and 10 IROs)

The IRO function for children and young people in care is separate from the chairing of child protection (CP) conferences, which is undertaken by the other arm of the reviewing service. KCC employs 11 CP chairs, which are incorporated into 1 county team, managed by a CP Chairs Team Manager. Together, the 2 IRO teams and CP Chairs team form one county service.

In May 2012 the capacity of the IRO service increased from 15 to 22 full-time IRO posts. A further increase of 2 full-time or equivalent IRO posts was agreed in April 2014 in order to reduce further IRO caseloads and enable IROs to undertake a more robust level of case oversight.

In addition to the permanent IROs within the service, the IRO service employs additional IROs on zero hour contracts (2 as at 31<sup>st</sup> March 2014) to assist in chairing reviews when there are vacancies/staff sickness.

# Independent Review Officer Service Annual Management Report 2013/2014

# **Summary**

The report provides an account of the performance of Kent County Council's Independent Reviewing Officer (IRO) Service for children and young people in care during the year 2013/2014 (1st April 2013 to 31st March 2014).

- IROs completed 4,685 quality assurance audits over the year, out of 5,220 reviews chaired; a 90% completion rate.
- IRO caseloads have been steadily reducing, although this trend needs to continue in order to enable them to be as effective as possible in their case oversight role.
- There has been some improvement in the participation of children and young people in care at their reviews. Further work is required to strengthen their participation and involvement.
- IRO activity data shows that there has been a drop in the amount of time IROs spend seeing children between reviews.
- The proportion of review meetings chaired within statutory timescales remains high (97.2%).
- The IRO service receives a late notification of children coming into care in approximately 20% of cases.
- There has been an ongoing improvement in performance in care planning. For example, in Q3 of 2012/13 65.8% of plans reached a "satisfactory" level or higher; this improved to 75.4% in Q4 of 2012/13, and to 74.8%, 78% and 79.9% in Quarters 1, 2, 3 respectively in 2013/14.
- There has been a significant drop in the proportion of social worker's reports for the review graded as "satisfactory" or better since the previous quarter (that is, from Q3 to Q4 of 2014). A key factor remains the timeliness of these reports being completed and provided to the IRO before the review.

- Only 15% of children and young people in care reported in questionnaires that they knew what the Pledge was.
- Around half of all the children and young people in care in Kent who responded to surveys said that they did not receive a copy of their care plan.
- 6% of children and young people in care in Kent who responded to the "leaving care survey" said they found it difficult to receive the support and help they needed after leaving care.
- Although carers were generally confident about IROs' practice and quality of service, they identified the following areas for improvement:
  - Having a better understanding of the role of IROs
  - having IROs contact numbers and being able to contact them in between reviews
  - o keeping the same IRO for the child in care
  - o cutting the length of reviews.
- Overall, comments from social workers and other professionals indicate that they
  find the IRO service to be very responsive and that it demonstrates sufficient
  case oversight.
- Parents are generally positive about the IRO service. However, they would like to receive reviews' minutes on time, have greater involvement in their child's review and discuss their concerns with the IRO before the review meeting.
