Subject: Appointment of Parent Governor Representative

Summary: To appoint one Parent Governor representative onto the Scrutiny Committee as required by the Local Government Act 2000.

1. Introduction

- (1) The Local Government Act 2000 requires the County Council to appoint Parent Governor Representatives to serve on the Scrutiny Committee (when education matters are discussed). In accordance with the Constitution (Section 17.49) two Parent Governor Representatives in total are appointed for a four-year term.
- (2) A vacancy was created when the previous Parent Governor took up a role as Vice Principal and Strategic Lead at Goldwyn School, Godington Lane, Ashford a Kent maintained school.
- (3) Nominations were sought from all Parent Governors at schools in the Kent Local Education Authority area. Two nominations were forthcoming by the stated closing date, so a secret ballot was held in October 2022. The successful candidate was Rebecca Ainslie-Malik, from Sittingbourne.
- (4) The supporting statement of Rebecca is available on request.

2. Recommendations

The Committee is asked to:

(a) confirm the appointment of Rebecca Ainslie-Malik as Parent Governor representative on the Scrutiny Committee for a four year term.

Subject: Outside Body appointment – Cranbrook School Trust

Summary: Selection and Member Services considers and determines appointments to Outside Bodies. A request has been made for clarification on the KCC appointment to the Cranbrook School Trust – the details are set out below.

1. Introduction

- (1) The Committee is charged with making appointments to outside bodies on behalf of the County Council. The Local Government and Housing Act 1989 political proportionality principles do not apply to these appointments, but in recent years it has been the County Council's convention that appointments should be shared between the political groups on, so far as possible, a proportional basis.
- (2) In September 2021, the Committee either made or confirmed a range of relevant Outside Body appointments. This included the appointment of one KCC Member to the Cranbrook School Trust. The individual Member selection to determine the person who will act as the KCC representative on Outside Bodies is, in practice, delegated to the Chief Whip (where representation is expected to be from the largest political group).
- (3) The Trust Deed for the Cranbrook School Trust allocates two seats to the Council. In practice, the second seat has historically not been taken up by KCC and has on occasion been filled by a non-KCC representative identified by the School and it should be noted that, as per the above paragraph, this Committee only made one appointment when determining Outside Body appointments in 2021. Due to the discrepancy between the Trust Deed and the recorded Outside Body appointments made by the Committee, arising out of good faith and continuation of accepted albeit informal arrangements, it is appropriate for the matter to be revisited formally and for the management arrangements to be clarified.
- (4) Therefore, to allow for smooth future management of this outside body situation and to provide clarity, it is recommended that the Committee confirm the Council's position on the use of the second seat legally allocated to the Council under the Trust Deed. The Committee may either determine that the Council will take up the seat open to them under the Deed and ask the relevant Political Groups to manage individual Member selection or the Committee can decide to confirm the existing arrangement that permits the School to nominate a non-KCC Member as a representative on the Trust in the relevant seat.

2. Recommendations

The Committee is asked to consider:

- (a) Allowing one seat, currently allocated to KCC under the School's Trust Deed but as yet not taken up, to be filled by a non-KCC person nominated by the Trust.
- (b) Delegate authority, in consultation with the Chair of Selection and Member Services Committee (and Chief Whip where appropriate) to the Democratic Services Manager, to implement this decision and update and manage the Outside Body Appointment lists to align confirmed appointments with existing Outside Body membership arrangements.

Subject: Member Remuneration Panel: Arrangements and Terms of

Reference

Status: Unrestricted

1. Introduction

- a) The County Council is responsible for agreeing the Members Allowances Scheme. A scheme, or an amendment, can only be agreed by Council if it has a report with recommendations before them produced by the independent Member Remuneration Panel (MRP). The regulations underpinning this system have been essentially unchanged since 2003. As part of the ongoing review and refresh of the Council's governance, it is an appropriate time to consider whether any changes are needed to the current process.
- b) This report only considers matters relating to the recruitment and terms of reference of the MRP and does not make any comment on the Member Allowances Scheme itself or content of previous MRP reports.
- c) The proposal presented in this report is a phased shift in how the process is managed. The core elements are:
 - 1. Agreeing the principle that the four-yearly scheme should be agreed prior to the start of the four-years to which it applies.
 - 2. Bringing the appointment date of the MRP members forward a year within the four-year Council term.
 - 3. Changing the recruitment method for Panel members.
 - 4. Updating the Terms of Reference of the Panel.

2. Starting Point of a Four-Year Scheme

- a) The long-established practice at Kent County Council has been to agree a four-year Members Allowances Scheme coterminous with a four-year Council term. The long-standing practice of the Council has been to agree the scheme after the elections and once the four-year Council term has already begun to which the scheme applies.
- b) Any annual uprating is now agreed as part of the budget and so are put into effect from the start of the financial year.
- c) There are some arguments in favour of waiting until after the elections to agree the four-yearly scheme such as being able to involve outgoing, continuing, and new or returning Members in the discussions. However, the 2003 regulations are clear that the scheme be agreed before the beginning of the (municipal) year.

d) Making the decision prior to an election for a scheme which will only impact those elected mitigates the conflict of interest inherent in Members agreeing their own scheme of allowances. It also allows candidates and those considering standing for election to know with more certainty what the allowances scheme will contain.

3. MRP Term of Office

- a) MRP members are currently appointed to four-year terms, with the current term ending on 31 October 2024. While this is six months ahead of the next election, the time needed to undertake, produce, and respond to the MRP report means a new scheme will be unable to be agreed prior to the election or the budget meeting.
- b) When the term of the current MRP expires, the new membership could be appointed to a term of three years on that occasion. This would bring the appointment of the subsequent MRP to eighteen months ahead of the election.
- c) However, this would not address the issue of enabling a report to be produced and scheme to be agreed ahead of the 2025 election November 2024 would perhaps be the most appropriate time for agreeing the Members Allowance Scheme to run from May 2025 for four years. This would allow it to be properly considered by those considering standing for election
- d) Subject to availability, the current MRP could be asked to undertake a second review in the final year of their term. Future appointments cannot be prejudged, so it is not certain that the same MRP members would be in post at the start and the end of the process.
- e) The way forward being proposed is that the next MRP is recruited next year in order to be appointed by Council and start its term on 1 November 2023. The MRP would therefore have a membership of between 3 and 6 for the period of a year depending on whether the current members applied and were appointed. From 1 November 2024, the MRP members would total 3.
- f) Assuming the changes proposed to the recruitment of the MRP are agreed, then this should be a straightforward process.

4. Recruitment of the MRP

- a) As set out in the Terms of Reference of this Committee and the Panel, the selection process of the MRP endeavours to put some distance between Members and those charged with making recommendations on their allowances. A selection panel of three non-Members is appointed by the Selection & Member Services Committee and they are responsible for making nominations as to whom Council should appoint. Historically, the selection panel has been composed of Honorary Aldermen.
- b) This indirect method of selection is unusual with no equivalent arrangement being found on surveying other Councils. It also adds several months to the process. In all other authorities reviewed the selection of names for nomination was conducting by senior Members, senior Officers, or a combination of both. Honorary Aldermen are not covered by the indemnity policy for Members and Officers. If there was a challenge to the recruitment process (including the

interviews carried out), this could potentially put the Honorary Aldermen at risk as well as being a reputational risk to the Council.

c) The principle of distancing Members from the recruitment in the current practice is a sound one. The recommendation therefore is that the Monitoring Officer is responsible for the recruitment/selection process of names for nomination, and this would require a change to the terms of reference of the Panel and a consequential amendment to that of the Selection and Member Services Committee (see appendix). Full Council will still have the final say when the full Panel is appointed.

5. Updating the Terms of Reference of the Panel

- a) The role and responsibilities of the MRP are clearly set out in the 2003 regulations. However, the terms of reference are currently not very detailed and could potentially lead to reports and recommendations from the Panel that either cover too little or too much. A review of other terms of reference showed that most contained more detail as to what the scheme should contain and therefore what the recommendations should focus on.
- b) The revision would also be an opportunity to correct an anomaly. The purpose behind the 2003 regulations was that the MRP report would provide an independent perspective from people unaffected by the scheme. However, the Panel are currently paid at the same day-rates as co-opted members. The MRP have a similar conflict of interest when considering an increase to the day-rates.
- c) Under the regulations, the Council may make provision to pay Panel members an allowance and/or pay expenses. This payment should not be part of the Members Allowances Scheme as Panel members are not Members or Coopted members. In addition, the last review was conducted virtually, and led to additional administration where the day rate was converted to an hourly rate.
- d) What is suggested is a straightforward allowance per review, plus appropriate expenses. The figures suggested in the draft terms of reference are based on examples from other authorities, and a consideration of the sums claimed for previous reviews.
- e) The suggested changes to the Terms of Reference are set out in the appendix.

6. Recommendation

The Selection and Member Services Committee is asked to:

- 1. Agree to support the principle that schemes should be agreed before the start of the year to which they apply.
- 2. Agree to bring forward the appointment of the MRP by one year within the four-year cycle.
- 3. Recommend to County Council that the Terms of Reference of the Member Remuneration Panel be amended as set out in the appendix.

Appendix – Proposed Revision of the Terms of Reference for the Member Remuneration Panel

The changes are not shown as track changes because the revisions largely replace the current content wholesale. The current terms of reference are set out in part two.

Part One – Proposed Terms of Reference

Member Remuneration Panel

- 17.10 The Member Remuneration Panel (MRP) is not a Committee of the Council and is established under The Local Authorities (Members' Allowances) (England) Regulations 2003.
- 17.11 Membership: 3 independent members.
- 17.12 No Panel member may be any of the following:
 - a) A Member or Co-opted Member of the Council or any of its Committees.
 - b) An individual disqualified from being or becoming a Member of the Council.
 - c) An employee of the Council.
- 17.13 Membership of the MRP will cease:
 - a) Automatically when any of the disqualifications listed in 17.12 apply.
 - b) Upon written notice of resignation sent by the Panel member and received by the Monitoring Officer.
 - c) Immediately upon resolution of County Council following recommendation by the Selection and Member Services Committee.
 - d) At the end of the term of appointment.
- 17.14 The Monitoring Officer shall be responsible for recruiting and recommending 3 individuals to the Selection and Member Services Committee for provisional appointment. The appointments are subject to confirmation by full Council.
- 17.15 Panel members are appointed for four years, or as determined by County Council at the time of appointment.
- 17.16 In the event of an interim vacancy in the Panel membership, the process in 17.14 will be followed with the Monitoring Officer recommending the same number of names as vacancies. The appointment is to run for the remainder of the original appointee's term unless otherwise determined by County Council.

- 17.17 On a four yearly basis, the MRP is responsible for reviewing the whole Members Allowances Scheme and making recommendations to the Council on the following:
 - a) The amount of the basic allowance.
 - b) The responsibilities and duties to allow the following to be received and the amount thereof:
 - i. Special Responsibility Allowance (SRA).
 - ii. Travel and subsistence expenses.
 - iii. Co-optees allowance.
 - c) The amount of the dependants' carers' allowance.
 - d) The implementation date for the new Members' Allowances Scheme and whether any payments should be backdated to the start of the municipal or financial year.
 - e) Whether there are to be any annual changes to the amounts received for a-d above; and where the changes are to be related to an index, the details of such an index.
- 17.18 In addition to the four yearly review, the Selection and Member Services Committee can request the MRP to conduct a review of one or more of the areas set out in 17.17(a-e) and make recommendations to the Council.
- 17.19 The MRP shall select from its number a Chair.
- 17.20 No Member of the Council has a right to attend its meetings and its procedures are determined by the Panel itself, subject to the requirement of a quorum of 3 Panel members when agreeing recommendations to make to the Council.
- 17.21 Upon completion of the four-yearly review under section 17.17, each Panel member shall receive an allowance of £1,000. Reasonable travel and other expenses shall also be paid.
- 17.22 Upon completion of a review under 17.18, each Panel member shall receive an allowance of £600. Reasonable travel and other expenses shall also be paid.
- 17.23 The Chair of the Panel shall receive an additional allowance of £200 upon completion of each review under both 17.17 and 17.18.
- 17.24 The work and recommendations of the Panel must conform to the relevant legislation.

Part Two – Current Terms of Reference

- 17.10 Membership: 3 independent members.
- 17.11 Independent Members of the Remuneration Panel are recommended to the Council for appointment by a Panel of three people (not Members of the Council) appointed by the Selection and Member Services Committee.
- 17.12 The Independent Remuneration Panel regularly reviews the Council's allowances and expenses scheme.
- 17.13 It meets on a regular basis and no one on the Panel is a Councillor or Council employee.
- 17.14 It has the responsibility for making recommendations to the Council on a scheme of allowances and expenses for Council Members and for reviewing that scheme in whole or in part as required by law or requested by the Selection and Member Services Committee.
- 17.15 The Panel is not a Committee of the Council. No Member of the Council has a right to attend its meetings and its procedures are determined by the Panel itself.

<u>Part Three – Consequential amendment to the Terms of Reference of the Selection and Member Services Committee</u>

Current Section 17.43(i)iv – This Committee is responsible for making or arranging the following appointments and nominations ... the selection Panel for the Independent Person and members of the Member Remuneration Panel.

This would be amended if the Terms of Reference set out in Part One are agreed by amending 17.43(i)iv to - This Committee is responsible for making or arranging the following appointments and nominations ... the selection Panel for the Independent Person.

A new Section 17.43(i)v would be inserted - This Committee is responsible for making or arranging the following appointments and nominations... members of the Member Remuneration Panel.

Overall Summary

186 grants were awarded in 2021/22, a period that was shortened due to the election which meant that grants were unable to be processed until the end of June 2021. The total amount of funding awarded was £237,631.54

Excluding Highways Grants (5 District Highways and 37 Kent Highways), during this period, 56 grants were awarded to previous recipients of a Combined Member Grant and 88 new recipients were reached. A range of organisations and groups were supported:

Community Safety Unit - Ashford Borough Council (21-AS-9) Exmoor Rise Repairs Initiative

£300

Contribution to the repair of the damaged chain link fencing at the end of Exmoor Rise to keep residents safe and act as a visual and physical deterrent to cutting across the fenced area. This is expected to reduce the likelihood of anti-social behaviour in the wooded area next to it and in the surrounding area.

Friends of Downs View Infant School (21-AS-11) Road Safety Workshops

£450

Member Grant Funding provided road safety workshops delivered to pupils who are aged between four and seven years old, with a total reach of 255 children. Each workshop was tailored to each age group to ensure that the pupils remained engaged throughout, to listen to the information about road safety and awareness.

Wye Tennis Club (21-AS-17) Contribution to the construction of padel tennis court £2000

Member Grant funding provided a contribution to the construction of a padel court for members, the first tennis club in Kent to have padel. The overall benefit is for exercising as well as improving mental wellbeing through sport and socialising.

St Michael's Village Community Group (21-AS-1)

Tributes in the Park

£500

A free annual music event with professional tribute acts for artists such as Elvis Presley as well as singers. This event was held to benefit of the mental wellbeing of the local community. KCC contributed funding towards performance artist fees.

Rolvenden Cricket Club (21-AS-2)2 New Scoreboard £3098

Member Grant funding enabled the replacement of the cricket club's pre-war scoreboard with an electric scoreboard. This has made it easier for players to see the score from all areas of the cricket ground and reduced the operating time which previously required three individuals. The electric scoreboard also allows residents to view the score from outside of the cricket club which has helped to attract attention and has highlighted the opportunities available to residents at the club. Future developments will see this linked to their online presence for instant updates.

St Michaels CEP School (Tenterden Schools Trust) (21-AS-7) Children and Older People Community Engagement £600

This project aimed to connect younger children with older people to reduce social isolation by providing the lunch provision one day a week for one school term of 6 weeks. The children and older residents attended Tenterden Social Hub to engage with each other, eat together and share life experiences. It is hoped that it may lead to volunteering when the children are older, as well as build on memories for all.

"This project has helped both older and younger generations become less distanced from each other and given a broader perspective about each of their positions in a community such as Tenterden."

Rolvenden Parish Council (21-AS-8) Red Phone Boxes Project £1498

This project involved the restoration of the exteriors of the red telephone boxes in the village. The telephone boxes were to be repurposed to become a 'sound museum'. One box will house a sculpture and artwork. The other box will play recordings of residents who are aged 80 and older recalling life in the village during their childhoods.

Orlestone Parish Council (21-AS-3) Hamstreet Community Fun Day £1000

A community day event was arranged with activities; in the afternoon, a children's party and family picnic was held for children living in the village to celebrate their birthdays who may not have been able to do so during the pandemic. This allowed the children to socialise and to feel connected with their community. KCC Member Grant funding helped to provide a marquee with tables and chairs.

Woodchurch Parish Council (21-AS-13) Defibrillator £1458

The residents in Six Bells Park area, who are primarily elderly or recently retired, identified that one of their greatest concerns was the lack of an accessible defibrillator within their area. Supported by a request from the local Residents Association, the Parish Council approached their local Member. KCC Member Grant funding provided the defibrillator, housing, signage, and fitting.

Charlie Simkins

The Charing Playing Field Trust (21-AS-6)
Alderbed Meadow Ash Die Back Appeal – Phase 1
£2000

Contribution to tree felling and clearance to replace 50 trees, which were unstable, dangerous and had ash dieback disease, with some new trees in the Alderbed Wood. The Wood is used as a recreational space by residents, the local school, and a scout group.

Bethersden Women's Institute (21-AS-15) Historical Archive Cabinet £1000

KCC Member Grant funding provided a fireproof filing cabinet to help solve the storage and accessibility issues that Bethersden Women's Institute were facing as they needed space for archiving nearly a century's worth of documents. The cabinet will ensure safe storage and preservation of key documentation for now and the future.

Bybrook Road Estate, Kennington (21-KHS AS-12) Contribution to 20mph scheme construction £9700

The group started with very little equipment and resources, Member Grant funding was requested to provide a contribution towards food, a computer console, sports equipment, arts & craft equipment and supplies.

Girlguiding 1st Wateringbury Guides (21-TM-29) Camping Equipment £1,540



1st Wateringbury Guides last went on camp holiday in August 2019 with 11 girls which was the maximum number that could attend due to limited equipment. At the beginning of October 2021, the unit was full with 36 Guides and 28 girls on the waiting list. However, only five Guides had ever been on a camp holiday and Member Grant funding was requested to provide a contribution towards six lightweight tents for a future trip.

Andrew Kennedy Burham Parish Council (21-TM-1) Litter Picking Equipment £500

Burham Parish Council employ a part-time litter picker to collect any rubbish within areas that are owned by the Parish Council including Burham Recreation Ground. Public areas such as roads and pavements were not able to be covered by the litter picker. Member Grant funding was requested to provide litter picking equipment, gloves and hi-vis jackets so that other areas can be covered.

"Feedback from school – my child now concentrates much better in school and is less disruptive in class..." "I'm much happier because I now have people to talk to on a weekly basis..."

60+ Club (21-TM-9) Outings for 60+ Club in 2021 £500

Many of the 60+ Club members live alone and due to COVID-19 had experienced a particularly sad and lonely time during lockdowns. The 60+ Club is often the only social event visited by members each week. At each club meeting, attendees socialise and chat over tea and coffee and homemade cakes and partake in various activities. Additionally, the club also visit various places across Kent Member Grant funding was requested to fund coach hire and a boat trip on the Kentish Lady.

Burham Parish Council (21-TM-11) Re-dedication of Burham War Memorial (100 Years) £1,000

Burham War Memorial was 100 years old during October 2021. The Parish Council wished to organise a re-dedication of the Memorial by holding a community event and requested Member Grant funding for bunting/flags, food & drink provisions, general tidying of the Memorial Gardens, temporary staging, a plaque and engraving.

St Peter & St Pauls Church Aylesford (21-TM-17) Food Bank £500

The food bank in Aylesford continues to meet the needs for families and individuals who are struggling to manage financially whether due to an inability to work, poor mental or physical health,

or job loss especially since the COVID-19 pandemic. The Church provides a food parcel, appropriate to the size of the family, to last for three days providing a balanced diet plus extras as available. Member Grant funding contributed towards food provision.

Wouldham Parish Council (21-TM-18)

Defibrillator

£500

Peters Village is a new housing development set within a rural location. Due to its location, it is popular with visitors, who along with residents make the most of the green open spaces.. Member Grant funding provided a contribution to an accessible defibrillator and cabinet.

Ditton Parish Council (21-TM-21) Unknown Tommy Statues for Village £350

In honour and memory of the local people who have served in world conflicts, the Parish Council requested Member Grant funding to purchase a pair of Tommy Statues for the village green and at the War Memorial.

60+ Club (21-TM-23)

Christmas Celebrations and Social Event

£300

The 60+ Club provides an opportunity to socialise and chat over tea and coffee; additionally, the Club participates in day outings and events. To celebrate Christmas, Member Grant funding contributed towards a Christmas lunch for 23 people.

Aylesford Colts FC U13 (21-TM-25) Renewal of Football Kits £500

Due to increased costs, Aylesford Colts were awarded Member Grant funding to renew their football kits with the aim to have a renewed focus in the community, inspire the teams and free up budgets to supply other vital football related equipment.

Ditton Infant School PTFA (21-TM-26) All Weather Daily Mile Running Track £1,000

As part of a fundraising initiative, Ditton Infant School are aiming to purchase an all-weather daily mile running track for pupils to use daily. This will assist pupils with their focus and attention in school, improve their mental health and enable them to have access to at least one form of physical exercise each day. Member Grant funding provided the track area markings.

St Peter & St Pauls Church Aylesford (21-TM-27) Aylesford Community Youth Choir £300

The junior choir had to stop because of COVID-19 restrictions. Experience has shown the benefits to children, meeting together as a team to learn new skills, and using them to perform in public. As soon as the restrictions eased, work was undertaken to re-establish a choir, this time on a wider basis. Thirteen young people have joined, mainly through contact with the three primary schools in

the parish. Member Grant funding was requested to purchase distinctive t-shirts, banners, and branded music folders for performances

Tonbridge Welcomes Refugees (21-TM-14)
Provision of Safeguarding Training
£1,000

Tonbridge Welcomes Refugees is a group of local people who welcome, support and work with refugee families who move to Tonbridge and Malling area including via the government's Syrian Vulnerable Persons Resettlement Scheme. Member Grant funding was requested to provide a safeguarding vulnerable adults and children training course for volunteers.

Domestic Abuse Volunteer Support Service (DAVSS) (21-TM-15) Awareness Campaign and Training Events £500

Member Grant funding provided promotional design work and printing to help the charity provide awareness raising and training sessions to health professionals, the police, and many other local organisations in order that they can spot the signs of abuse and provide advice, as well as signposting.

The Hygiene Bank (21-TM-20) Expanding Provision in the Tonbridge locality £500

The Hygiene Bank receives large quantities of hygiene products from the Kent community and has successfully distributed over 19,000 kg of essentials to more than 46 community partners including food banks, mother and baby services, homeless shelters, churches, schools, nurseries, community kitchens and refuges. To continue to operate at maximum capacity and ensure successful storage to assist with distribution, Member Grant funding was requested to contribute towards leasing costs of a storage facility within the Tonbridge locality.

RefugEase (21-TM-24) Free Furniture Collection Service Campaign £547

Member Grant funding was requested to provide advertising and promotion of a free furniture collection service scheme to prevent landfill, promote recycling and provide cheap second-hand furniture to the local Tonbridge community.

Following concerns raised by residents, farmers, and the Parish Council with the local Member about excessive driver speeds on parts of Seven Mile Lane, Member Grant funding was requested to conduct a public consultation and write a legal TRO for the proposed speed limit change.

Borough Green (21-KHS-TM-28)

Provision of load testing of street lighting columns to enable the attachment of festive decorations and hanging baskets to KCC streetlights £1,500

In conjunction with Borough Green Parish Council, Member Grant funding was requested to ensure that columns were structurally capable of receiving the attachments and keep highway users safe.

A project spread across two days, Rock in the Rec and Carnival Fete, provided local community events in July 2021. Member Grant funding contributed towards first aid, toilet facilities, clean up and PA systems.

Benenden Community Shop (21-TW-4) CCTV System Upgrade £1,000

Benenden Community Shop, Café and Post Office began operating in 2015 with the aim of preserving the shop and post office in the village, whilst providing a café which would become the village hub. It is run by a mix of paid staff and volunteers. The shop had a basic CCTV system installed when the premises were refurbished. However, it proved inadequate to deal with the security issues which the shop faced. Member Grant funding contributed to cameras, back boxes, and video recorder.

The Bridge Trust (21-TW-7) 2 Door Replacements £2,000

The Bridge Trust's aim is to provide what is needed to get homeless people from the local streets and out of whatever other, unsatisfactory homeless situation they are in. Their work extends to supporting clients into training, volunteering, and work. The Trust had rented 3 one-bed flats to

Tunbridge Wells Borough Council who were using them for their government sponsored "Housing First" initiative, by placing homeless people directly into this accommodation. Member Grant funding contributed to the cost of two replacement front doors.

Tunbridge Wells Youth for Christ (21-TW-8) The Noise 2022

£500 (£1,000 total award)

A joint award with Paul Barrington-King. The Noise is an established project which has been hosted by different churches across the town over the years. Past projects have helped churches reach out into their communities to set up new projects such as a Kids Club, a regular church service in a sheltered housing complex, a community garden, and a craft club. Member Grant funding provided refreshments, t-shirts, and publicity

Hospice in the Weald (21-TW-9) Air Purifiers £2,000

For people with a terminal illness, COVID-19 presented a significant risk to them as they often had already severely weakened immune systems. Whilst shielding at home was an option for some, others came into the Hospice either for in-ward care for complex health conditions and end-of-life care. Member Grant funding enabled the Hospice to purchase new, top-of-the-line air purifiers to help minimise the potential spread of any virus in the Hospice, protecting patients, visitors, staff and volunteers.

Southborough SOS Volunteer Group (21-TW-10) Litter picking equipment £605

In 2021 Southborough SOS Volunteer Group collected 2377 sacks of rubbish plus enough fly-tipped junk to fill six large skips, all from local roads, housing estates and green spaces. In 2021 the Group was a runner up finalist in the Tunbridge Wells Borough Council "Love Where You Live Awards" for Best Group. Member Grant funding provided a foldable litter picking cart and litter segregation cart.
