LIST OF FORTHCOMING EXECUTIVE DECISIONS

Each week the list of Forthcoming Executive Decisions is updated where there are additions, deletions or amendments to be made. Although Kent County Council aims to include all known decisions, statute requires that all Key decisions must be publicised in this way.

A “Key Decision” is an Executive-side Decision which is likely to:

- (a) result in the council incurring expenditure which is, or the making of savings which are, significant having regard to the council’s budget for the service or function to which the decision relates; or
- (b) be significant in terms of its effects on communities living or working in an area comprising two or more electoral divisions in the area of the local authority.

Key Decisions can only be taken by the Cabinet, the Leader or an individual Cabinet Member.

Decisions which should be regarded as Key Decisions because they are likely to have a significant effect either in financial terms or on the Council’s services to the community include:

- (a) Decisions about expenditure or savings over £1,000,000 which are not provided for within the approved budget or Medium Term Financial Plan
- (b) Adoption of major new policies not included in the Policy Framework (Constitution Appendix 3) or significant changes to established policies
- (c) Decisions that involve significant service developments, significant service reductions, or significant changes in the way that services are delivered, whether County-wide or in a particular locality. For example, closure of a school, approval of a major project (such as a highway scheme) or programme of works, major changes in the eligibility criteria for provision of a service, major changes in the fees charged for a service, or proposals that would result in a service currently provided in-house being outsourced.
- (e) Decisions where the consequences are likely to result in compulsory redundancies or major changes in the terms and conditions of employment of a significant number of employees in any of the Council’s functions.

Preparation of the list helps the Council to programme its work and ensures compliance with the ‘Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) regulations 2012.

The list outlines the consultation that is proposed in respect of future decisions and who members of the public and the Council should contact to make comments on any particular item. Anyone is entitled to obtain copies of the documents that will be relied upon when a decision is taken, unless those documents are ‘Exempt’ within the meaning of the relevant sections of the Local Government Act 1972 (as amended).

Reports related to decisions will be published on the Council’s web site at www.kent.gov.uk at least five days before the decision it is due to be taken. Once the decision has been

<p>Latest Update: 19/05/2014: Decision due date changed from 23/12/2013 to 'Not before' 01/11/2014. REASON: The disposals team at KCC are currently working on new plans for the site in order to ensure that the maximum value for the site is secured. Options appraisal work is underway and this work is expected to take approx. 6 months, therefore an expected decision date is set for November.</p> <p>-----</p> <p>To seek approval to proceed with the disposal of the above site to raise a capital receipt which will be allocated to support the capital programme.</p> <p>To seek approval to identify and progress with the acquisition of a new site for the service.</p> <p>The Director of Property and Infrastructure Support will be authorised to finalise terms for both the disposal and acquisition of a new site.</p> <p>This decision is needed to enable a modern highway service operation to be provided in the East Kent Area that is both reactive and responsive to changing demands. It directly supports 3 of the Bold Steps for Kent.</p> <ul style="list-style-type: none"> • Firstly it helps deliver the “Kent Environment Strategy” by the provision of new environmentally friendly facilities (e.g. grey water) via the construction technique with the eventual adaptation of new work practices within the new depot. • Secondly it builds relations with key business sectors across Kent as the supply chain involved in such a project provides work to businesses of all sizes. • Thirdly by the better siting and provision of facilities for the new depot it ensures that the most robust and effective public protection arrangements are in place for road management including bad weather response. <p>The impact of the decision is that full assessment of the potential disposal of the site can be explored within the market place to ensure that best value principles are adhered to. Yes. KCC's approach to Growing Places Fund has been discussed by the Economic Development Cabinet Committee on 5 July 2012 and 21 September 2012 (although these discussions did not include the specific allocation of GPF investment to Discovery Park).

In addition, the proposed Decision will be discussed by ED Cabinet Committee on 14 June.

The Growth, Economic Development and Communities Cabinet Committee will consider a report on this decision on 2 December 2014.

Other consultation

Consultation on this proposal has taken place with the South East Local Enterprise Partnership Board, which has endorsed the provisional allocation of £4.6 million from the Growing Places Fund for use at Discovery Park. Consultation has also taken place with Dover District Council.

Reference No: 14/00135 and 14/00136	Key Yes Reason if Key Decision:
Charging for Adult Social Care, Deferred Payments and Temporary Financial Assistance	
<p>This issue will be dealt with by two decisions:</p> <p>Decision 14/00135 - Charging for Adult Care and Support: That Kent County Council exercise its power under Section 14 of The Care Act 2014 to charge, from 1 April 2015, for the same adult social care and support services that it currently charges for, as at 31 March 2014.</p> <p>Financial Implications: In relation to this decision specifically, there are not expected to be significant financial implications for 2015-16 as there will be no change to the groups of people and services that are charged/charged for. Further, the details of how to charge individuals (as laid down in The Care and Support (Charging and Assessment of Resources) Regulations 2014) do not depart significantly from the current system until April 2016. From April 2016 there will be financial implications from charging due to the raising of the capital threshold for people in residential care whose former home is taken into account in the financial assessment. In addition the wider Care Act changes will have significant financial implications.</p> <p>Legal Implications: The decision is believed to be necessary in order for the Council to be able to continue to charge in the same way as it currently does</p>	

for residential and non-residential care and support. Currently local authorities have a duty to charge for residential care (under section 22 (1) of the National Assistance Act 1948) and a power to charge for non-residential services (under section 17 of the Health and Social Services and Social Security Adjudications Act 1983, which Kent does exercise for most non-residential services). These powers and duties will cease from April 2015 and are being replaced by a power to charge under section 14 of the Care Act 2014.

Equality Implications: It was considered whether an Equalities Impact Assessment should be carried out but it was decided this was not necessary as there will be no substantive changes to which people are charged for care and support and for which services.

Decision14/00136 - Deferred Payments and Temporary Financial

Assistance: That Kent County Council introduces the new Deferred Payments scheme from 1 April 2015 (with both mandatory and discretionary elements). It is further recommended that the current Temporary Financial Assistance scheme should cease after 31 March 2015 as the new Deferred Payments scheme will cover the same groups of individuals.

Financial Implications: It is expected that there will be more people taking up the new Universal Deferred Payment scheme than the current Deferred Payment and TFA schemes combined. Currently there are about 50-100 new DP or TFA cases each year. It is estimated that from the introduction of the new scheme there will be 300-400 new applications each year. The costs to administer these will be largely covered by the admin charges which are permitted and the interest which will be added to the cost of the loan (the maximum interest being laid down by Government). There are implications in terms of cash flow but the money will generally be repaid as it secured on the individual's property. Secured debt will however increase as a result of the changes. This will be largely unavoidable as most of the new scheme is mandatory.

Legal Implications: The rules governing the new Deferred Payments Scheme from April 2015 will allow wider discretion in the ability of councils to pay for an individual's residential care who would otherwise be expected to pay the full cost but whose capital is not accessible (usually because it is tied up in a property). This will cover those situations currently covered by the discretionary Temporary Financial Assistance scheme (for example, when the property is jointly-owned or there is already a mortgage on it). It is not, therefore, believed to be necessary to maintain the Temporary Financial Assistance scheme.

Equality Implications: It was considered whether an Equalities Impact Assessment should be carried out but it was decided this was not necessary as the new Deferred Payments scheme will encompass the types of people currently covered by the current Deferred Payments scheme and Temporary Financial Assistance.
