LIST OF FORTHCOMING EXECUTIVE DECISIONS

Each week the list of Forthcoming Executive Decisions is updated where there are additions, deletions or amendments to be made. Although Kent County Council aims to include all known decisions, statute requires that all Key decisions must be publicised in this way.

A “Key Decision” is an Executive-side Decision which is likely to:

- (a) result in the council incurring expenditure which is, or the making of savings which are, significant having regard to the council’s budget for the service or function to which the decision relates; or
- (b) be significant in terms of its effects on communities living or working in an area comprising two or more electoral divisions in the area of the local authority.

Key Decisions can only be taken by the Cabinet, the Leader or an individual Cabinet Member.

Decisions which should be regarded as Key Decisions because they are likely to have a significant effect either in financial terms or on the Council’s services to the community include:

- (a) Decisions about expenditure or savings over £1,000,000 which are not provided for within the approved budget or Medium Term Financial Plan
- (b) Adoption of major new policies not included in the Policy Framework (Constitution Appendix 3) or significant changes to established policies
- (c) Decisions that involve significant service developments, significant service reductions, or significant changes in the way that services are delivered, whether County-wide or in a particular locality. For example, closure of a school, approval of a major project (such as a highway scheme) or programme of works, major changes in the eligibility criteria for provision of a service, major changes in the fees charged for a service, or proposals that would result in a service currently provided in-house being outsourced.
- (e) Decisions where the consequences are likely to result in compulsory redundancies or major changes in the terms and conditions of employment of a significant number of employees in any of the Council’s functions.

Preparation of the list helps the Council to programme its work and ensures compliance with the ‘Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) regulations 2012.

The list outlines the consultation that is proposed in respect of future decisions and who members of the public and the Council should contact to make comments on any particular item. Anyone is entitled to obtain copies of the documents that will be relied upon when a decision is taken, unless those documents are ‘Exempt’ within the meaning of the relevant sections of the Local Government Act 1972 (as amended).

Reports related to decisions will be published on the Council’s web site at www.kent.gov.uk at least five days before the decision it is due to be taken. Once the decision has been

This matter will be discussed by Cabinet Committee on 30th June 2017.

This strategy has been jointly produced with Kent Police and developed in partnership with the many stakeholders from across Kent and organisations directly involved with addressing the effects of drugs and alcohol across the County, including Public Health Kent, Trading Standards and the Kent Drug and Alcohol Partnership (KDAP).

An earlier draft of the strategy was open for formal consultation via the Kent County Council website from early January 2017 until late February 2017. A number of updates to the strategy have been made following feedback received. There were also a number of focus groups as part of the consultation process. These were conducted with offenders at HMP Elmley, Service users from East Kent, West Kent and Children and Young People's Services and Mental Health Service Users. The draft strategy was also presented at various partnership meetings including Community Safety Partnerships, Health and Wellbeing Boards (County and Local), CCG Clinical Leadership Teams and Joint Kent Chiefs.

17/00064 Coroners Post Mortem Contract

The Coroners and Justice Act 2009 places a duty on Coroners to investigate deaths that are referred to them if they have reason to think that:

- The death was violent or unnatural;
- The cause of death is unknown; or
- The deceased died while in prison, police custody or another form of state detention e.g. where a Deprivation of Liberty Safeguard Order (DoLS) is in place

In some cases the Coroner will order a PM to establish the cause of death. In these cases, bodies are taken to a pre-designated mortuary. In 2016 of 1,973 deaths referred to the Senior Coroner for North West Kent, 750 required a PM (38% of deaths referred).

On behalf of the Senior Coroner, KCC ensures there is adequate storage capacity for Coroner's bodies and that the Coroner has access to PM facilities. KCC does not have its own public mortuary facility and so like many other coroner areas across England and Wales it has always used local NHS hospitals which have the necessary facilities for this purpose as there are no private sector providers of PM facilities anywhere in England and Wales.

Currently, post mortems for the Mid Kent & Medway coroner area are carried out by Medway NHS Trust at Medway Maritime Hospital. The last contract expired on the 31st March 2017 and a new four year contract has been agreed for the period 1 April 2017 to 31 March 2021.

17/00051 - A274 Sutton Road, Maidstone, at its junction with Willington Street

The Maidstone Integrated Transport Package (ITP) aims to reduce congestion and ease traffic movements through the town.

Willington Street connects the A20 and A274 routes which are the two key corridors into Maidstone from the east and south east. The scope of this first phase of the strategy is to improve the operation of the junction at the northern end of Willington Street with the A20 Ashford Road and the junction

at the southern end of Willington Street with the A274 Sutton Road. At present, these signalised junctions at each end of Willington Street are heavily congested under peak traffic conditions.

In March 2016, a proposed scheme was discussed and welcomed at the Environment & Transport Cabinet Committee. However, further work on this scheme shows that it will not deliver the intended benefits and therefore a re-design was required. As the re-design is significantly different to the original scheme discussed, the revised scheme is being presented to Environment and Transport Cabinet Committee.

TfSE would provide a mechanism for the area to speak with a strong, common voice on transport infrastructure and provide a single platform for strategic transport and infrastructure issues, giving partners greater, and potentially direct, influence over decisions that are currently made elsewhere. Its key outcome will be the development of a single, strategic transport infrastructure framework which would align the investment programmes from key agencies, such as Highways England, Network Rail and the LEPs.

- Set up the SNTB for Kent and Medway, but this would not be supported by DfT
- Engage in the development of the Shadow SNTB Board and Transport Strategy for the Southeast

How the proposed decision meets the objectives of ‘Increasing Opportunities, Improving Outcomes: Kent County Council’s Strategic Statement (2015-2020)’

The cornerstone of TfSE is the Transport Strategy. It will build upon existing Local Transport Plans, including Kent’s *Local Transport Plan 4: Delivering Growth without Gridlock*, currently out to consultation, and evidence already in place amongst the constituent Authorities, including the LEP’s Strategic Economic Plans and growth and infrastructure frameworks/studies being undertaken by a number of upper-tier Authorities, including the *Kent and Medway Growth and Infrastructure Framework*. 2018/19 and 2019/20

Agreement will be sought from the Cabinet Member for Children, Young People and Education to revise the term dates for the school years 2018/19 and 2019/20.

In March 2016, the Cabinet Member for Education and Health Reform agreed to determine the school year term dates for 2017/18, 2018/19 and 2019/20. This followed a six week consultation with all schools and other key stakeholders such as governors (including parent groups), the diocesan bodies, trade unions and other neighbouring authorities. The general public was also encouraged to participate.

Feedback from this consultation included a request from a few teachers that Term 5 should end later in 2018/19 and 2019/20 to help regulate the length of each term.

Subsequently, the decision was taken to extend Term 5 in 2019 from 23 to 27 days with term ending on 31st May 2019 and Term 6 beginning on 10th June 2019. In 2020, Term 5 was extended from 25 to 28 days with term ending on 29th May 2010 and Term 6 beginning on 8th June 2020.

Since this decision, examination dates for secondary school pupils have been released by Exam Boards/Awarding Bodies. In 2019 and 2020, secondary education level exams have been scheduled to take place during the first week of June. It is therefore necessary to hold a consultation on the proposal to revise the date on which Term 5 ends in both 2019 and 2020.

The outcome of this consultation and revised term dates for 2018/19 and 2019/20 will be reported to the Children, Young People and Education Cabinet Committee taking place on Thursday 22nd June 2017.

- Thirdly by the better siting and provision of facilities for the new depot it ensures that the most robust and effective public protection arrangements are in place for road management including bad weather response.

The impact of the decision is that full assessment of the potential disposal of the site can be explored within the market place to ensure that best value principles are adhered to. In tandem a full search and feasibility study will be undertaken to identify a new location for the alternative highways depot which satisfies the above objectives.

The impact of the decision will be that KCC will have less control of the management and operation of the centre as they would become the responsibility of a third party.

Risks identified are:

- Reliance on the professionalism of the trustees to deliver a successful facility, agreeing with all partners a financial model for the charitable vehicle
- Reputational damage to KCC if the charitable vehicle were to fail
- Obtaining buy in from all community groups in occupation to form trust
- Untried and untested model
- Level of income generation from the centre which could go to the charitable vehicle is currently unknown as a new facility
- Continued KCC ownership of a non-core asset
- Officers may be unable to get agreement from stakeholders, charitable vehicle does not prove financially sustainable or the trust may break down and

charitable vehicle will have to pick up void periods and associated costs (benefit to KCC).
