## **FORWARD PLAN OF DECISIONS**

Each month the Council publishes a Forward Plan of Decisions expected to be taken during the following six months.

A “Key Decision” is an Executive-side Decision which is likely to:

- (a) result in the council incurring expenditure which is, or the making of savings which are, significant having regard to the council’s budget for the service or function to which the decision relates; or
- (b) be significant in terms of its effects on communities living or working in an area comprising two or more electoral divisions in the area of the local authority.

Key Decisions can only be taken by the Cabinet, the Leader or an individual Cabinet Member.

Decisions which should be regarded as Key Decisions because they are likely to have a significant effect either in financial terms or on the Council’s services to the community include:

- (a) Decisions about expenditure or savings over £1,000,000 which are not provided for within the approved budget or Medium Term Financial Plan
- (b) Adoption of major new policies not already included in the Policy Framework (Constitution Appendix 3) or changes to established policies
- (c) Approval of management and business plans
- (d) Decisions that involve significant service developments, significant service reductions, or significant changes in the way that services are delivered, whether County-wide or in a particular locality. For example, closure of a school, approval of a major project (such as a highway scheme) or programme of works, major changes in the eligibility criteria for provision of a service, major changes in the fees charged for a service, or proposals that would result in a service currently provided in-house being outsourced.
- (e) Decisions where the consequences are likely to result in compulsory redundancies or major changes in the terms and conditions of employment of a significant number of employees in any of the Council’s functions.

Preparation of the Forward Plan helps the Council to programme its work and ensures compliance with the Local Government Act 2000. Every month, the period covered by the Plan will be rolled forward by one month and the plan will be republished.

The Plan outlines the consultation that is proposed in respect of future decisions and who members of the public and the Council should contact to make comments on any particular item. Anyone is entitled to obtain copies of the documents that will be relied upon when a decision is taken, unless those documents are ‘Exempt’ within the meaning of the relevant sections of the Local Government Act 1972 (as amended).

Reports related to decisions will be published on the Council’s web site at [www.kent.gov.uk](http://www.kent.gov.uk) at least five days before the decision it is due to be taken. Once the decision has been taken, a copy of the Record of Decision will also be published on the Council’s website.

**Reference No:** The 1990 Town and Country Planning Act (as amended by the Planning and Compensation Act 1991) established the statutory framework for developer contributions in the form of Section 106 planning obligations. Our Development Contributions team within Economic Development department ensure that our requests comply and have appropriate governance in place.

**20/00016 - Section 106 Funding**

**The Decision needed:**

**Background:**

KCC receive developers' contributions (S106) to support the additional demand on services for young people created as a result of new housing developments. Currently, KCC has secured almost £1.3m of S106 funding for youth services, with a further £582k awaiting process. There is a further £1.5m that has been approved and will become payable once houses are built. Kent's growth agenda will result in many new housing developments planned. As these reach planning, ICS will request a youth S106 contribution. This is currently being based upon a figure in the region of £7 per home. Working with KCC Property and Infrastructure, ICS are now in an early stage of 'testing' an increase figure of £65.50 per home, for youth work, which is based upon a greater understanding of our service as current thinking is based on a model which pre-dates the development of an integrated service where we may have just wanted some delivery space in every new development but which was not targeted or joined up.

**Proposed decision:**

The Cabinet Member for Integrated Children's Services proposes to take the following decision:

- i. Approve the introduction of four dedicated area based detached youth work teams, using S106 funding to cover staffing and associated equipment costs, as set out in the report.

- ii. Approve the allocation of £2k per district to each Local Children’s Partnership Group (LCPG), to be spent over two years, to ensure the inclusion of young people’s voice across the district (total cost of £24k). This spend is to be agreed by LCPG and overseen by the Area Partnership Managers.
- iii. Acknowledge that whilst some of the S106 will be spent on youth capital costs, this will not be in replacement of Total Facilities Management/Property and Infrastructure budget and responsibilities.
- iv. Approve the remainder of the S106 funding to be considered to provide additional capacity in youth teams and any local district projects. This may also include costs associated with a Fleet Review.

**Reason if Key Decision**  
 An EqlA has been completed as part of the process and will be presented to the CYPE Cabinet Committee so it can be considered as part of the decision-making process. It is expected that the impact on protected groups will be largely positive, given the proposed opportunities to engage with young people to ensure that their voice is heard and fully incorporated into plans for provision delivery. Young people could represent a number of protected groups.

**Consultees**

This decision will be discussed at the Children’s, Young People and Education Cabinet Committee on 11 March 2020.

No formal community consultation. However, the proposals are based upon meeting the need of community regarding services for young people in regard to a contextual safeguarding methodology. Actual areas of focus will be led by the District Contextual Safeguarding meetings and adolescent risk management processes.

Opportunities to engage with young people will be facilitated through the Local Children's Partnership Groups and district Contextual Safeguarding Network, to ensure that their voice is captured in making plans to utilise this funding.

Whilst the S106 funding releases additional budget, it is noted that future receipts are not guaranteed. The programme aims to ensure that this is continually reviewed every 18 months in regard to sustainability post the 2 years initial aim.

£1.3m S106 funding allocated to be spent on youth provision. Of this, £13k must be spent on Capital projects and the remainder (£1.27m) can be spent on areas that ICS is able to identify as benefiting from this resource (within the criteria that there is additional demand on services created as a result of new housing developments). ICS have identified opportunities as per the decisions outlined above.

A further £582k of Section 106 funding has been requested but not yet approved. Once approved, this figure can be added to the above figure of future receipts. In addition to the secured S106 funding, ICS have a projected income stream of £1.5m. This is money that has been allocated to KCC as housing developments have been approved.

**20/00017 - Recommissioning of Early Help Services**

**The Decision needed:****Background:**

The vision of Early Help and Preventative Services is that every child and young person and their family, who need Early Help services, will receive them in a timely and responsive way, so that they are safeguarded, their educational, social and emotional needs are met, and they achieve good outcomes.

In November 2016, KCC commissioned several Early Help and Preventative Services to complement and support the development of the internal provided Early Help Services. These services include:

- The Family Support Service – a service to provide early support for families experiencing difficult challenges.
- The NEET Service – offers support to those young people who have been either NEET in excess of 6 weeks or whom have experienced multiple periods of NEET.
- The Young Carers Service – a bespoke service that offers support to young people who have a caring responsibility within their family unit.

Since commissioning these service, KCC's Children, Young People and Education Directorate has undergone a transformation programme integrating internal services to develop the new Integrated Children's Service. This has included the enhancement of the adolescent offer, investment in training and development, new practice models and the development of a single 'front door' for all referrals.

Recommissioning the Early Help services will ensure alignment with the new service arrangements. The existing contractual levers have been utilised to extend all three services until 30<sup>th</sup> September 2020, allowing the recommissioning to take place alongside the work currently being undertaken to refocus the Early Help element of the Children and Young Person's Mental Health Service into alternative evidence-based services/interventions.

**Proposed decision:**

1. Recommission a range of Early Help and Preventative Services in line with changes to KCCs Integrated Children's Services and the Local Transformation Plan for Children and Young People's Mental Health Services. Affected Services are:
  - The Family Support Service
  - The NEET Service
  - The Young Carers Service
2. Delegate authority to the Corporate Director for Children, Young People and Education, or other nominated officer to undertake the necessary actions to implement the decision.

An EQIA has been completed as part of the process and will continue to be reviewed as we progress the work. The services in scope form part of the wider Early Help offer and are designed to address the assessed needs of a child and their family through evidence-based interventions. Targeting of services will be based not only on individuals and groups with protected characteristics but also other areas of risk and vulnerability such as deprivation, substance misuse and mental health.

This work does not represent a significant service change. The contracts have been in place since 2016 and are performing well. Commissioners have started to consult with key stakeholders as part of the recommissioning exercise and will continue work with internal and external stakeholders (including Members, current service providers and the wider market) to best understand how the services should be shaped going forwards. Any proposed amendments to the current service provision will be communicated to schools, police and health providers and take into consideration the voice of the child. Where possible services will be co-designed by service users and young people will form part of the tender evaluation panels.

**The Decision needed:**

**Background Information:**

Local authorities have had the ability to charge for residential care (under section 22 (1) of the National Assistance Act 1948) and for non-residential services (under section 17 of the Health and Social Services and Social Security Adjudications Act 1983) for a number of years, this is not a statutory requirement, but Kent County Council (KCC) utilised this ability for most non-residential services.

Statutory guidance on charging for residential and non-residential care and support under the Care Act 2014 section 14 is provided in the [Care and Support Statutory Guidance](#). All previous guidance documents, such as the [Charging for Residential Accommodation Guide](#) and [Fairer Charging Guidance](#) came to an end on 1st April 2015, ceasing these powers and duties.

KCC exercised its power under Section 14 of The Care Act 2014 to continue to charge at the same rates and in the same ways from 1 April 2015 after the Care Act bill was passed.

KCC has been more generous with its charging policy since it began charging in 2002 and has not made any significant changes to its charging policy since 2011. KCC has now had to review the subsidies that it provides to some people to ensure consistency, fairness and the best use of its funds to support all its Adult Social Care clients.

The project has been initiated to look to amend sections of KCC discretionary charging in the Non-Residential Charging Policy to align it with the government's Department of Health's (DoH) guidelines.

These changes will look to align KCC with a standard charging model employed by the DoH and several other local authorities.

To amend the Adult Social Care and Health Non-Residential Charging Policy to align with the Department of Health's Minimum Income Guarantee guidelines and delegate authority to the Corporate Director of Adult Social Care and Health, or other nominated officer, to implement the decision.

**20/00012 - Temporary arrangements for Transfer Station Services for Folkestone & Hythe municipal waste**

**The Decision needed:**

**Proposed Decision**

To provide authority to the Head of Waste Services to agree a new supply of temporary arrangements for Transfer Station services for Folkestone & Hythe’s municipal waste.

**Background**

Kent County Council is the Statutory Waste Disposal Authority for the County managing the disposal of Waste Collection Authority’s kerbside collected waste, delivered to Transfer Station facilities throughout Kent.

Due to the completion of the East Kent Waste Partnership, this transfers the title of recyclable waste to KCC in January 2021. KCC needs to plan for the receipt, bulking and haulage services for kerbside waste collected within Folkestone & Hythe District Council as the limited existing facility is no longer available within the District.

The waste categories and tonnages involved, require extensive permitting arrangements at sensitively located facilities in the east of the County to mitigate the need for Waste Collection vehicles to exceed administrative areas.

The Contract will be for temporary services whilst KCC considers a bid for capital funding for a Transfer Station to be constructed within the District. The Transfer Station services will facilitate segregation and management of the waste to avoid the use of landfill as a disposal option and maximise recycling levels.

**The Decision needed:**

**Background** – Across Kent, the number of pupils with an Education, Health Care Plan (EHCP) has increased significantly. Between January 2015 and January 2019, the number of pupils aged between 0 -25 years of age with an EHCP increased from 7,374 to 11,763 an increase of 60%. The increase in the overall number of pupils with an ECHP is having an impact on the need for places within our special schools and the specialist resourced provisions (SRPs) within mainstream schools. Dover District is one of only two Kent Districts without a PSCN special school (the other being Dartford). In order to address this, The Commissioning Plan for Education Provision in Kent 2019-23 identified the need for a new 168 place PSCN provision from September 2020. The County Council retained the Walmer Science College site for future educational needs. A feasibility study has shown that, once refurbished, the buildings and site would be suitable for more ambulant PSCN pupils across the 3-19 year old age range. Having a building such as this available will allow us to open the provision quicker than would have otherwise been expected and possibly with an initial phase as early as September 2020.

**Options** – The need for a new provision for either PSCN or ASD within Dover was set out in the Commissioning Plan for Education Provision in Kent 2019-23. The Area Education Officer has been open about the need for this provision with Kent’s special schools. Officers have decided that The Beacon School Folkestone, as an outstanding special school, is in the best position to successfully open the satellite provision.

**Proposed decision** – To release £4,000,000 from the Children’s, Young People and Education Capital Budget to enable The Beacon Folkestone to open of a satellite provision at the former Walmer Science College and increase the designated number of the School to 548 places.

**Background** – Goldwyn School is a maintained special school designated to support pupils aged 11-16 years with Social, Emotional and Mental Health needs (SEMH). It is judged as Outstanding by OFSTED. Presently the school is designated to take 115 pupils aged 11-16 years of age. However, due to the increased need for specialist SEMH places the School has been commissioned to provide up to 150 places for the last few years. This proposal would formalise the current situation, while at the same time increasing the age range to 18 years in order to add a sixth form, adding a further 45 post-16 places, taking the final designated number to 195 places.

**Options** - No other option were considered as this is the only SEMH specialist School in the District

- (i) Change the age range at Goldwyn School, Ashford from 11-16 years to 11-18 years in order to add sixth form provision, adding 45 post-16 places, and

2. Participate in, and cooperate with, Transport for the South East in accordance with the powers requested from Government and those powers operating concurrently with Kent County Council as Highway Authority and Local Transport Authority.

And delegate authority to the Corporate Director of Growth, Environment and Transport, in consultation with the Leader and Monitoring Officer, to enter into relevant legal agreements and take other appropriate actions as necessary to implement the decision.

### **Background**

The Cities and Local Government Devolution Act 2016 amended the Local Transport Act 2008 to allow the creation of Sub-national Transport Bodies (STBs). There are now several shadow STBs in England, with Transport for the North becoming the only statutory STB in April 2018.

The South East 7 (SE7 – Kent, Medway, Surrey, West Sussex, East Sussex, Hampshire, Brighton and Hove) councils proposed the establishment of an STB for the South East. From this, Transport for the South East (TfSE) emerged, which is now a partnership of 16 Local Transport Authorities and five Local Enterprise Partnerships. In addition to the SE7, TfSE includes Southampton, Portsmouth, Isle of Wight, and the Berkshire unitary authorities represented by the Berkshire Local Transport Body (West Berkshire, Wokingham, Windsor & Maidenhead, Bracknell Forest, Reading, Slough).

TfSE has sought to formalise its role as the South East's voice for strategic transport issues by becoming a statutory body. To do this, TfSE has worked with its members to develop a Proposal to Government. This draft proposal was consulted on from May to July 2019. KCC provided a response to the consultation, supporting the powers TfSE proposed. Some of these were supported only conditionally provided that the principle of subsidiarity is applied (i.e. powers are used at the most local level). This was in relation to highways and transport functions that constituent members already hold but TfSE wants to enact concurrently.

Transport for the South East have since revised their Proposal to Government taking account of the comments they received in the consultation. The revised Proposal includes the application of the principle of subsidiarity.

TfSE has also consulted on its draft Transport Strategy for the South East (October 2019 – January 2020). KCC responded positively to this consultation to support the overall aims and aspirations of TfSE. The development of a Transport Strategy is one of the central functions of a STB, and the Department for Transport awarded TfSE funding (in addition to funding from the constituent authorities) to produce one.

TfSE plan to submit the revised Proposal to Government and the Transport Strategy for the South East to the Department for Transport concurrently. This is to present a unified vision for the region alongside the request for powers to achieve it, with the consent of constituent bodies.

## Strategic Statement

Transport for the South East is emerging as an important advocate of improved transport in the region, and its own aims closely match the objectives of the Strategic Statement. The vision for the Transport Strategy for the South East is:

*By 2050, the South East of England will be a leading global region for net-zero carbon, sustainable economic growth where integrated transport, digital and energy networks have delivered a step-change in connectivity and environmental quality.*

*A high-quality, reliable, safe and accessible transport network will offer seamless door-to-door journeys enabling our businesses to compete and trade more effectively in the global marketplace and giving our residents and visitors the highest quality of life.*

Thus, TfSE is fundamentally focused on improving lives, sustainable economic growth, and supporting all people to make informed transport decisions and have a range of transport choices so that they can benefit from improved quality of life. Consequently, TfSE has the potential to positively contribute towards all of the supporting outcomes identified in the Strategic Statement.

## Options

Kent County Council is one of the founding bodies of Transport for the South East. As such, the only other option would be to decline to endorse the Proposal to Government and rescind support for TfSE. This would restrict KCC's opportunities to progress transport schemes for investment and isolate the county from wider regional discussions about transport in the future. It could potentially see the Council's influence in lobbying for schemes on the Strategic Road Network and railway network diluted because KCC would be a small area alone, hence not in alignment with the move to regional prioritisation that the Government has promoted to date.

The Kent Commissioning Plan for Education 2019-2023 identifies a need for additional places in the Canterbury City Planning Area from 2021 this is due to pressures from new housing developments in Canterbury City and specifically the private development on the former Howe Barracks Site. This development will produce a total of 500 new homes. In addition to this, the refurbishment of former army houses by Redbridge Council is resulting in 38 new families moving in from November 2019. To mitigate the need for places, it is proposed that Pilgrims Way will expand by 0.5 forms of entry (FE) to become a 2FE Primary school. Pilgrims Way is the nearest primary school to these developments and was named for any developer contributions linked to the development of private housing on the former barracks site. Canterbury City Council Local Plan identifies 16,000 new homes over the plan period to 2031. 8,737 are planned for the Canterbury area, with 6,533 in the Canterbury City Primary planning area where Pilgrims Way Primary School is located. Pilgrims' Way Primary School was registered as a new school on 1st May 2018 and is part of the Veritas Academy Trust. They are awaiting their first Ofsted inspection. Currently Pilgrims Way has 261 on the school roll with 31 on the nursery roll totalling 292 (May school census 2019)

To expand Pilgrims Way Primary School by increasing the Published Admissions Number (PAN) from 45 places to 60 places from September 2021.

It is anticipated that there will be significant short and medium-term pressure for additional Year 7 places in the Gravesham and Longfield Non-Selective Planning Group which indicates that additional capacity will be needed for 2021 and in later years.

Therefore, KCC has asked Meopham School to provide additional places for local children by expanding the school.

KCC propose increasing the accommodation and the amount of school social space including, dining, recreational and circulation space over the expansion period. This work would be completed before the September 2021 intake. This build would enable the school to offer 210 Year 7 places for September 2021.

#### **Options:**

Meopham School is a popular school that was judged 'Outstanding' by Ofsted in February 2019.

There are seven secondary schools in the Gravesend and Longfield Non-Selective Planning Group. These are: Longfield Academy, Meopham School, Northfleet School for Girls, Northfleet Technology College, Saint George's CE School (Gravesend), St. John's Catholic Comprehensive School and Thamesview School.

Of these, Thamesview School, St George's CE School, Northfleet School for Girls are either being expanded, or are the subject of a future proposal to expand. Northfleet Technology College is under feasibility for an expansion and Longfield School has been offering additional places under local arrangements for several years. Meopham School is the only remaining candidate for expansion.

Meopham School is a popular and successful school and the proposal to increase the number of secondary places at the school is therefore, in line with the expectation of expanding popular & successful schools. The proposal is to add an additional 70 places taking the school PAN up to 210 for September 2021. It will be achieved through building additional accommodation and service space on the Meopham School site.

Applications will then be appraised and considered through the same process as that which is currently used to determine applications for loans from the Kent and Medway Business Fund (KMBF).

This means that any application will be required to submit a full business plan, be subject to independent appraisal and be considered by the KMBF Investment Advisory board before a decision is made by KCC. The owners of the Discovery Park site are aware of this proposed process and we anticipate that an application will be forthcoming when the process is launched. In parallel with this process, KCC shall seek to enter into a loan agreement with Essex County Council (the Accountable Body for GPF). These terms have been discussed with Essex County Council and have received an in-principle agreement. However, they will need to be formalised when an agreement to lend to a borrower have been reached.

The alternative would be for Kent County Council not to act as an agent for SELEP for the £5.3m Growing Places Fund loan. KCC forecasts indicate a growing demand for Year 7 places in Gravesham from the start of the 2019-20 academic year. The Gravesend and Longfield Selective Planning Group is forecast to have a deficit of 36 Year 7 places (1FE) from 2019-20 that increases to a deficit of 62 places (2FE) for the 2021-22 intake and increases again to 99 places (3.3FE) by 2023/24.

Gravesend Grammar School has a Published Admission Number of 174, but has in the past, offered extra places through appeals.

KCC proposed an expansion of the school to take the PAN to 210 (7FE). The school currently has a permanent infrastructure that can accommodate a PAN of 150. There is a temporary two storey block on site that offers additional accommodation, facilitating the extra 24 places. ### **Background**

A previous Key Decision was taken by the Cabinet Member for Environment and Transport on 1 August 2014 (14/00056) which approved the delivery of Thanet Parkway Station in the location to the west of Cliffsend, involving:

- a) Commencing land acquisition work;
- b) Undertaking public consultations to support the project development process; and
- c) Undertaking project development work to enable the submission of a planning application and design work for the scheme.

The feasibility design for the scheme received Approval in Principle (equivalent to Network Rail's 'Governance in Railway Investment Projects Stage 3' [GRIP 3] status) in August 2017. Following that milestone, the scheme was progressed through outline design (GRIP 4) and planning application was submitted in May 2018.

Comments received during the planning process regarding the visual impact of the scheme led to changes in the scheme design. As a result, the

design work and planning application documents have been amended and are being readied for a resubmission of the planning application in November 2019.

Negotiations for land acquisition have been ongoing with the intention to enter into a contract following this decision approval.

A decision is required to proceed with the delivery of the scheme in order to meet the project delivery programme.

A full options analysis has been carried out as part of the scheme business case (Appendix 1). Below is a summary of the options considered as alternatives to delivering Thanet Parkway.

KCC has committed £2.65m and will commit to funding the remaining amount whilst continuing to explore further external funding opportunities.

The business case work has been completed, showing that the project offers high value for money and that the station is commercially viable (net fares revenue is in excess of the on-going cost). Depending on the operating model, there is the potential for the station car park to provide a future income to KCC over a number of years.

**Background:**

Kent County Council took the decision to enter into an innovative partnership with Kent Community Health Foundation Trust (KCHFT) in September 2017, with the aim to maximise the opportunity to improve the health of Kent residents, deliver common objectives and accelerate delivery of the Sustainability Transformation Plan (STP), known as the Sustainability Transformation Partnership. This arrangement was also designed to offer the flexibility to align to new local care arrangements.

This decision recognised that KCHFT was integral to the delivery of the STP and recognised that both KCC and KCHFT faced significant challenges which could be better managed through a joint open and transparent approach. The original decision put procurement in “abeyance” until at least March 2020 and a further decision is required on how best to deliver these services in the future. Legal advice taken at this time confirmed that the approach was permitted within the Procurement Regulations.

The Kent and Medway Sustainability and Transformation structures are more advanced than in 2017 and local leaders are working to deliver the local plan, Case for Change. This includes a series of commitments which have been supported by KCHFT. Kent and Medway STP is developing a five-year plan in response to the national LTP and is required to become an Integrated Care System (ICS) in the coming months. Services and health providers will need to align to these changes and work with commissioners to determine how they can best integrate and support acceleration of local care.

Kent continues to face a series of significant demographic pressures alongside budget constraints and pressures, e.g. long-term clarity on national NHS pay and uncertainty on future funding arrangements for the Public Health grant.

*Mrs V Tovey, Public Health Senior Commissioning Manager, was in attendance for this item.*

1. Mrs Tovey introduced the reports for agenda items 8 and 12 and responded to questions of detail from the committee, including the recruitment

and training of new nurses and retention and re-training of experienced nurses to take on new roles, for example, as health visitors and school nurses, to offer a new career pathway. The Care Quality Commission's recent rating of Kent Community Health NHS Foundation Trust (KCHFT) as 'outstanding' would help to retain and attract new staff. Other questions included clarity of the conditions that were required to be met for the County Council and KCHFT to enter into this agreement. Mrs Tovey confirmed that the conditions were set out in section 12(7) of the Procurement Regulations and also referenced within the exempt report. Mrs Tovey informed the committee that independent legal advice confirmed the arrangement met these criteria for the delivery of public health services and advised that this would be subject to review during the five years to ensure the conditions continued to be met.

2. It was RESOLVED that:-

- a) the context, risk and assurance associated with the proposed procurement approach for public health services be noted; and
- b) the decision proposed to be taken by the Cabinet Member for Adult Social Care and Public Health, to authorise the County Council to extend the collaborative arrangement with Kent Community Health NHS Foundation Trust, for the services listed in the report, until March 2025, be endorsed.

The spend of Public Health services across the 5 years will be in the region of £187,109,535. However, values will be subject to annual review and will fluctuate based on demand and any external investment e.g. through Health partners.

Additional income through Health Partners enables delivery of HIV treatment services and targeted work for NHS Health Checks as set out as part of the STP.

The estimated value for 2019/20 is £37,421,907 with anticipated income of £860K from NHS England and the Kent and Medway STP. Services included are Health Visiting, School Nursing, Postural Stability, Sexual Health, Lifestyle services, including Smoking, and NHS Health Checks and Oral health. A number of services are open-access and, as such, actual spend will be dependent on demand.

In January 2017 permission was agreed to release £2,200,000 from the Education and Young People's Services Capital budget to enable Palmarsh Primary School to expand to 1FE. It was understood that this would be the first phase of a gradual expansion to 2FE.

The first phase of the expansion would provide 3 new classrooms, a new entrance off Jubilee Close, offices and car parking with further classrooms being added in later phases.

Planning permission for the first phase of the expansion has been achieved. However, in order to secure the said planning permission significant adaptations needed to be made increasing the capital costs to £2,600,000.

Options:

Consideration has been given as to how we can scale back the first phase of the expansion plans, ensuring there is: is sufficient high quality classroom space for the school to expand to 1FE; provision of a new entrance off Jubilee Close; increased car parking and the completion of agreed s278 works.

Sufficient classroom space could be achieved via the removal of an old mobile classroom and replacing this with a new two classroom mobile unit. The new offices and permanent classrooms could be delivered in a later phases as an when there is a need for second FE of provision. The total costs for the mobile classrooms, new entrance off Jubilee Close, car parking and s278 works would be in the region of £700,000.

A variation to the present planning permission will be required if this was to proceed.

- Thirdly by the better siting and provision of facilities for the new depot it ensures that the most robust and effective public protection arrangements are in place for road management including bad weather response.

In tandem a full search and feasibility study will be undertaken to identify a new location for the alternative highways depot which satisfies the above objectives.

The proposal directly links to Bold Steps for Kent, putting the citizen in control, building new partnerships and providing a new fit for purpose building to deliver Library and FSC services in conjunction with other partners such as the Citizen's Advice Bureau and House (West Kent Action), to support Kent's more vulnerable citizens.

The impact of the decision will be that KCC will have less control of the management

and operation of the centre as they would become the responsibility of a third party.

Risks identified are:

- Reliance on the professionalism of the trustees to deliver a successful facility, agreeing with all partners a financial model for the charitable vehicle
- Reputational damage to KCC if the charitable vehicle were to fail

- Untried and untested model
- Level of income generation from the centre which could go to the charitable vehicle is currently unknown as a new facility
- Continued KCC ownership of a non-core asset
- Officers may be unable to get agreement from stakeholders, charitable vehicle does not prove financially sustainable or the trust may break down and charitable vehicle will have to pick up void periods and associated costs (benefit to KCC).
