## Summary and recommendations of equality analysis/impact assessment.

#### Context

KCC as the Local Authority has a statutory duty to ensure sufficient school places are available. The County Council's Commissioning Plan for Education Provision in Kent 2020-24 is a five-year rolling plan which is updated annually. It sets out our future plans as Strategic Commissioner of Education Provision across all types and phases of education in Kent. A copy of the plan can be viewed from this link:

The Kent Commissioning Plan 2020-2024 identified the need for additional selective places for the Canterbury and Faversham Planning group. Forecasts indicted a deficit of Year 7 places of up to -37 places in 2023 and a continual need through the plan period of between 0.5FE and 1FE.

Forecast below includes Simon Langton Grammar School for Boy at a PAN of 150 as the PAN was increased during in- round admissions consultations for the intake for September 2020.

It is anticipated that there will be medium-term pressure for additional places. KCC has also commissioned a feasibility to expand Queen Elizabeth Grammar School in Faversham to meet the additional forecast need for places by expanding the school from a PAN of 140 to 180 (6 forms of entry)

# Who have you involved consulted and engaged?

Simon Langton Grammar School for Boys consulted during the in-round consultation process to increase it's PAN from 120-150. KCC will consult with partners during the pre-planning process.

## **Analysis**

There is no evidence that the change will impact negatively on pupils from Protected Groups or lead to them being treated less favourably. The school continue to welcome pupils regardless of gender identity, race, ethnicity or religion beliefs.

## Adverse Impact,

No adverse impacts have been identified at this stage

## **Positive Impact:**

The proposal to expand Simon Langton Grammar School for Boys will offer much needed additional selective secondary school provision in the Canterbury and Faversham selective planning group area. This will allow more local pupils the opportunity to attend the popular school and will ensure the PANs for the Girls and Boys Grammar School are brought closer together. The expansion is intended to be implemented incrementally, with 30 additional Year 7 places offered in each year, so that the school would grow over a 5-year period until it reached a total of 750 Year 7-11 places.
