10.12.08	Highways Business Plan IMG 02.12.08 - A list of gully schedules be supplied to all Members after the elections	In July Members will be supplied with specimen gulley emptying schedules following the completion of route optimisation work for gulleys countywide. When all this is complete, gulley emptying schedules will be available.
09.12.09	Kent Design Guide	A residential parking workshop was held on 14 April 2010. Mr Chard, Cabinet Member for Environment and Waste has agreed to review current Government parking guidelines, the outcomes of the workshop on residential parking guidelines in the Kent Design Guide, and Kent Developers Group proposals so that they are not unnecessarily disadvantaged. A report will be presented to Environment Highways and Waste Policy and Overview Committee on this issue at its meeting in July.

	- Ask for written confirmation that the total cost of administering the process and overheads is no more than 10% of the total cost of the contract	Confirm that admin/supervision costs will be below 10% - this is confirmed and detail will be provided to Environment, Highways and Waste Policy Overview & Scrutiny Committee at the 29 th July meeting
	- Ask that Members, Parish Councils and Town Councils be informed when teams will be working in their areas	The programme has now been made available and Members, Parish and Town Councils have been informed
	- Ask that the frequency of inspection of utilities work to road surfaces is increased to ensure benefits and high performance of utility companies.	We currently meet our obligations under the New Roads and Street Works Act, we will shortly however be increasing the amount of reinstatements that we inspect. 	The Committee are aware of a range of important initiatives being undertaken which will improve the quality and flow of information to elected Members for example implementation of the Informal Member Group: Member Information (approved by the County Council – December 2008), the enhancement and refresh of the County Council website and the decision to develop Kent Digital Service. 	cohesiveness in pulling all these factors together and a lack of clarity over who has the overall vision which the Committee recommends must be addressed. The Deputy Leader and Cabinet Member for Localism and Partnerships be asked to report to the Scrutiny Board on how and when he proposed this work to be taken forward, and this be reported to Members of Cabinet Scrutiny Committee through their follow up items report.	There is a need to ensure that this information is available to non-executive Members so that they can be effective community leaders who can add value to the decisions taken by the Executive and the County Council.
