






% of Gravesham population aged 0-5 compared to Kent


Gravesham: 0-5 Population by Ward







Gravesham: Children Living in Relative Low-income Families (CiLIF)

Profile of the 0-5 population

% of 0-5s living in a relative low-income family in Gravesham compared to Kent



The children in low income families (CiLIF) statistics provide information on the number and proportion of children living in Relative and Absolute low income before housing costs (BHC) in the reference year. A family must have claimed one or more of Universal Credit, Tax Credits or Housing Benefit at any point in the year to be classed as low income in these statistics.

In 2021/22, <u>1,500</u> children aged 0-5 lived in a relative low-income family in <u>Gravesham</u>, which is <u>18.9%</u> of the 0-5 population in the district. The rate for Kent is 16.4%.







There were <u>371</u> children aged 0-5 in <u>Gravesham</u> with an Early Help (EH) case in 2021/22, which is a rate of 4.7% of the 0-5 population in the district. This is <u>lower</u> than the Kent rate of <u>4.8%</u>.

There were <u>429</u> children aged 0-5 in <u>Gravesham</u> with a social care care or referral in 2021/22, which is a rate of <u>5.4%</u> of the 0-5 population in the district. This is <u>higher</u> than the Kent rate of <u>4.9%</u>.



The age is calculated as of 31/08/2022 and unborn are included in the figures for 0 year olds. The rates have been calculated using the 2021 ONS mid-year estimate population figures.



Gravesham: Health Visitor Performance


Proportion of health visits or checks completed within target time in 2021/22, compared to the Kent rate (turquoise line).

Healthy Child Clinic rates

There were 673 Healthy Child Clinics held in Gravesham in 2021/22. This means that there were 1 clinic held for every 1.9 children aged under 1-years-old*.

This is a <u>higher</u> rate compared to Kent overall (1 clinic held for every <u>2.9</u> children aged under 1-years-old).

Breastfeeding Groups rates

There were 82 Breastfeeding Groups held in Gravesham in 2021/22. This means that there were 1 group held for every 15.2 children aged under 1-years-old*.


This is a <u>lower</u> rate compared to Kent overall (1 group held for every <u>8.1</u> children aged under 1-years-old).

Gravesham: Visits to Children Centres



In the 2021/22 academic year, children centres had visits from 961 children aged 0-5 who lived in Gravesham, which is rate of 12.0% of the 0-5 population in the district. This is higher than the Kent rate of 10.1%.

In total, there were 5,407 visits to children centers in 2021/22 from children aged 0-5 who lived in Gravesham.






Gravesham: Take-up of Free Early Education by 3 & 4 Year Olds






Universal entitlement

All 3 and 4 year olds are entitled to up to 15 hours of free childcare each week for 38 weeks a year, or fewer hours per week over more weeks of a year (up to 570 hours).



In <u>Gravesham</u> in the summer term 2022, <u>55.9%</u> of 3 and 4 year olds had taken up Free Early Education (FEE) and <u>23.4%</u> had taken up Extended Funded Entitlement (EFE). Overall take-up was 79.4%.

In comparison, for Kent the take-up rates were $\underline{87.5\%}$ overall, 53.0% for FEE and 34.6% for EFE.

1.3% of 0-5 year olds in Gravesham have an EHCP. The rate for Kent is 1.2%.

The most common need type among 0-5 year olds in Gravesham is Speech, Language and Communication Needs (51.4%).

The EHCP data includes all children aged 0-5 on 31 August 2021. The rates have been calculated using the 2021 ONS mid-year estimate population figures.

Of the <u>1,324</u> children assessed in <u>Gravesham</u>, <u>66.8%</u> of Year R pupils achieved a Good Level of Development in the Early Years Foundation Stage (EYFS) profile in the 2022 assessment.

This is <u>higher</u> than the Kent rate of 65.4%.
