Scrutiny Committee on 26th March 2008 in relation to Item E1 -

Modernisation of Queen Elizabeth Resource Centre, Dartford

1. The Purpose of Consideration for Cabinet Scrutiny Committee on 26th March 2008 was:

- (a) to establish what consultation, if any, has taken place with service-users;
- (b) if consultation has taken place, to establish what information serviceusers were given and, in particular, whether they were advised of the options for alternative provision
- 2. The decisions made were:
 - (a) Mr Lynes, Mr Mills, Mrs Howard, Mrs Holden, Ms Henry, Mrs MallionMr Wright be thanked for attending the meeting to answer Members questions
 - (b) The Managing Director be requested to give further consideration of the need for a base for operations in the area to ensure that no service users were over looked.
 - (c) The Cabinet Member and the Managing Director be advised that the Cabinet Scrutiny Committee would like to be assured that future consultation on changes to service provision should follow a standard format whether KCC is the provider or the commissioner of the service.
- 3. Kent Adult Social Services would like to respond as follows:
 - (b) Part of the proposal for the modernisation of services is to have three centres; one in Dartford, one in Gravesend and one in Swanley. These centres will be in community buildings and will provide disabled people an opportunity to meet in an environment which has staff on hand to provide assistance, signpost and co-ordinate.

These will form the 'base for operations' and will be free for Kent residents and ensure that no service users are over looked.

(c) KASS acknowledges Cabinet Scrutiny Committee's advice in respect of consultation on future service variations. KASS procures some 85% of its

services from external providers; these services include domiciliary, residential, nursing home and day care, through a range of different contract and agreement models. Increasing numbers of people are commissioning their own services by using Direct Payments. Wherever possible KASS will consult with current service users in the spirit of the consultation procedure for the closure or variation of use of a KCC service. The principles of this procedure were followed for the modernisation of QEF. There will sometimes be circumstances where this is not possible – where, for example, an independent provider decides to change a service for business reasons it will not then be possible to follow a standard format for consultation.
