Reason(s) for decision, including alternatives considered and any additional information

Background

In summer 2011, KCC (on behalf of the Sandwich Economic Development Task Force) applied to the Government's Regional Growth Fund for a £40 million programme of assistance for the districts of Canterbury, Dover, Shepway and Thanet. This programme sought to:

- a) Establish a programme of direct financial assistance to existing businesses and inward investors in East Kent, known as Expansion East Kent; and
- b) Maximise the benefit of High Speed One to East Kent by providing part-funding to line speed enhancement between Ashford and Ramsgate.

The Government has approved funding for the full programme, allocating £35 million for the Expansion East Kent project and £5 million for the Line Speed Enhancement project. The Government has since issued a separate draft Grant Offer Letter for each project. More details are provided in the attached appendix.

Reasons for decision

A decision is required under the terms of the Council's Constitution because KCC has received draft Grant Offer Letters for both projects and must decide whether or not to enter accept the Government's offers of funding.
