# Reason(s) for decision, including alternatives considered and any additional information

Kent County Council's (KCC) modernisation of Day Services for Adults with Learning Disabilities is an integral part of the transformation towards more personalised services reflecting the vision and strategy contained within "Valuing People Now" White Paper (January 2009) and KCC's "Active Lives". This is underpinned by the "The Good Day Programme — Better Days for People with Learning Disabilities across Kent", which will ensure people have a wider range of choice, more control and equality of opportunity so that they may lead a full and meaningful person centred life.

Gravesend SEC (GSEC) will be improved and modernised due its location and well established links with the community. Additionally, the co-location of the LD Care Management Team as part of the council's New Ways of Working Programme will strengthen professional support. This will enable an improved and more community-based service to be provided for GSEC service users.

## Cabinet Committee recommendations and other consultation:

Formal consultation with service users, carers and staff took place 20 January – 28 February 2014 and local members and opposition groups were briefed during this. Consultation strongly supported the proposed refurbishment.

The 12 June 2014 Adult Social Care & Health Cabinet Committee considered the recommendation report and proposed decision. In response to a local member's query, officers confirmed that concerns about parking and mature trees had been addressed with a proposed reconfiguration of the car park.
