

I declare the following Relationships which MAY fall within the definition of a Related Party Transaction although, in the interests of complete transparency, I have, as in previous years, taken a precautionary view and declared relationships which may fall below the threshold of a formal declarable Related Party Transaction.

AGE UK NORTH WEST KENT

I have been appointed as an unremunerated Observer on the Board of AGE UK NWK. Although I have no decision making powers I participate in meetings and understand that a reasonable person may consider that I have greater influence over its decision-making than a person who is not present at such meetings.

Age UK NWK receives ANNUAL funding from KCC for various social and day care activities related to the elderly.

THE LEIGH ACADEMIES TRUST

I am unremunerated Director of the Leigh Academies Trust, operator of several schools and Academies in Dartford and the south east. The Trust may, from time to time, have a number of contracts with KCC for educational services related to the operation of the Schools and whilst the commissioning of such services would be operational decisions for the professional leaders of each school, I serve on a Board which has responsibility for budgeting and general oversight of the Trust.

LONGFIELD AND NEW BARN PARISH COUNCIL

I am a (practically) unremunerated (Members receive a £100 allowance per anum) and Elected Member of Longfield and New Barn Parish Council which may, from time to time, benefit from Grants from KCC and be involved as a consultee on KCC services such as street-lighting and Public Rights of Way.

DARTFORD BOROUGH COUNCIL

I am a remunerated elected Member and Leader of Dartford Borough Council which has various dealings with KCC, receives various grants and is engaged in various joint-working on intitatives ranging from Troubled Families to Youth Services.

DARTFORD FOOTBALL CLUB

I am an unremunerated Director of Dartford Football Club which may, from time to time, make application to KCC for Sport and Community funding for its work encouraging an interest in Sport, although I am aware of no current contracts, transactions or grants.
