The number of children entering our Pent Valley Technology College each year is very small and these low numbers are not expected to increase significantly within a reasonable timeframe. This means that the number of pupils on roll at the College is diminishing.

Schools receive funding based on pupil numbers and the decline in numbers results in a corresponding decline in funds available to the College. This means that it will be impossible to maintain the current staffing levels necessary to maintain and sustain the improvements required.

#### **Aims and Objectives**

- To ensure that every student currently in Year 7, 8 and 9 attending or who has applied for a place in Year 7 at Pent Valley Technology College for September 2016 secures a school place at their nearest appropriate school operating within KCC policy and procedures, in particular, with regards to Admissions, Transport and support for SEN.
- To ensure that students in the current Year 10 who remain on site have the opportunity to complete their GCSE studies with the support of Swale Academy Trust.
- To ensure the current Year 11 students are supported in making alternative and suitable decision on the post-16 options.
- To ensure that current Year 12 students secure their transfer to suitable courses to complete their post-16 studies.

#### Parents and Carers

There will be a meeting with parents and carers 15 December 2015. All families will be offered the opportunity for one to one discussions to look at their preferences and the needs of their children before the end of the consultation period.

#### **Public**

The consultation period will run from 06 January to 03 February 2016.

A Public Meeting will be held at the College on 18 January 2016.

Following the consultation period, feedback as a result of the consultation will be reported to KCC Education & Young People's Cabinet Committee on 17 February 2016. A decision to issue a public notice will be taken by the Cabinet Member or Education and Health Reform. The public notice period (if issued) will be 25 February to 24 March 2016.

The decision on closure will be taken by the Cabinet Member for Education and Health Reform at the end of the public notice period.

#### Staff

Consultation will be undertaken with staff and their respective professional associations according to agreed policy and procedure. Early consultation will commence on the 06 January 2016.

## Disability

## **Adverse Impact:**

Any potential adverse impact that students may experience from a move to a new school will be countered through close working with the Pent Valley Technology College staff, those at the receiving schools and parents/carers around their individual needs; consideration of transport requirements (within the constraints of current agreed KCC policy) particularly for those where financial constraints may have an adverse impact; provision of uniform costs; placement of siblings together; work with other local schools to agree additional capacity where required to meet the needs of children currently attending Pent Valley Technology College. Any adverse impact will be the subject of ongoing consultation and evaluation to ensure equality of treatment for all pupils and that mitigating action is put into place.

### **Positive Impact:**

The move to a school/academy in a stronger financial position and who have thriving rolls should enable the individual needs of children to be met and provide greater opportunities and a broader curriculum for students. Those attending larger schools/academies will benefit from the larger staffing and, therefore broader range of skills that a larger staffing should be able to provide.
