Part 1: INITIAL SCREENING (05/05/20)

Context

Kent County Council is looking to extend the current Organic Processing Contracts for organic waste deposited at the Household Waste Recycling Centres and kerbside collected organic waste. From January 2021, KCC will have title to the additional household waste collected kerbside from the East Kent area.

As a Waste Disposal Authority, the provision of such waste disposal services is a statutory obligation under the Environmental Protection Act 1990.

Waste Management is able to meet the KCC's Strategic Statement – Key Supporting Outcome "Kent's physical and natural environment is protected, enhanced and enjoyed by residents and visitors" by managing Kent resident's organic waste in the most efficient and effective manner through using the waste hierarchy as a measure of how Kent is moving waste away from landfill and prioritising the material to use it for processing and recycling.

Aims and Objectives

From immediate effect (1st April 2020) Kent County Council will:

 Extend the Processing of Organic waste contracts for initially 4-years and a further 2-years thereafter as specified within the Contracts for organic waste deposited at the KCC HWRCs and collected kerbside in West and Mid by the WCAs and from January 2021 further organic waste collected kerbside in the East of Kent when the title of this material returns to KCC Waste Management.

Beneficiaries

The intended beneficiaries are householders in Kent disposing of organic waste at the HWRCs and collected at the kerbside by the Waste Collection Authorities.

Data

As the Waste Disposal Authority, Kent County Council is responsible for ensuring that all waste disposed of at Kent HWRCs and collected kerbside is disposed of correctly in the most financially efficient way. The disposal of this waste is a 'back office' procedure, with all 'customer facing' elements of this process the responsibility of the HWRCs.

Potential Impact

This Equality Impact Assessment is a screening to indicate potential areas of impact, both positive and negative, to the diverse population of Kent, which could result from the extension to the contracts to process the Authority's waste arisings.
