1. INTRODUCTION

Laleham Gap School was established in April 2005 as the county's specialist provision for high functioning pupils aged 3 to 16 years with Autistic Spectrum Disorder and/or Speech and Language disorders. The new school was established from the amalgamation of Laleham School and Gap House School and since 2005 has continued to operate across both sites.

Through the Government's Building Schools for the Future programme, secondary and special schools in Thanet are benefiting from substantial capital investment. This has enabled Kent County Council to bring forward this proposal to build a new school for Laleham Gap School to a design of the highest quality. It will mean that for the first time the school can be consolidated in purpose built buildings on a single site.

This document contains details of why Kent County Council is proposing to relocate Laleham Gap School and gives details of how you can respond to this consultation.

Implementation of the proposal is subject to the outcome of this consultation and decision making process and the timescale is outlined on page 6.

2. THE PROPOSAL

The proposed location of the new school buildings is on greenfield space which currently is exclusively occupied by the new Ellington and Hereson School. The site is large and was always envisaged as being suitable for up to 3 schools.

Although Laleham Gap School and The Ellington and Hereson School would be relatively close, they would each retain their own separate and distinct buildings and facilities, although the possibility of deriving added value from the sharing of sports facilities would be carefully explored.

The Kent County Council Building Schools for the Future team would work with the school on 'visioning' for their new school buildings. The new school buildings would be designed to provide innovative accommodation to suit the needs of the pupils and provide the best possible learning environment.

The new buildings would accommodate 164 pupils, 44 places for pupils aged 3 to 11 years, 120 places for pupils aged 11 to 16 years, and include 60 residential spaces.

There is a public right of way running through the proposed location of the new building. Careful consideration will be given to this to ensure that the footprint of the new buildings makes optimum use of available space. Consideration will also be given to ensuring that access to the site is suitably adapted to accommodate the needs of Laleham Gap students.


















3. WHAT ARE THE BENEFITS OF THIS PROPOSAL?

- Currently Laleham Gap School is located on two sites and this proposal would consolidate the school on one site. Secondary aged students currently attend the Laleham site in Margate and primary aged students attend the Gap House site in Broadstairs. The existing Laleham site itself is divided by a footpath and the accommodation on both sites is unsuitable for the long term needs of the school.
 - It would be very difficult to adapt the existing Laleham Gap sites because of the space available and the constraints of the existing accommodation.

- Following this consultation, all views received, either in writing, by email or at the Public Meeting, will be reported to the School Organisation Advisory Board of Kent County Council.
- A Cabinet Member decision will be made on whether to take the proposal forward.
- If so, a Public Notice will be published in a local newspaper, at the school and in public places like the library. The Public Notice will run for six weeks. Representations about the proposal can be made.
- A determination will then be reached on whether the proposal is to be implemented.
- In certain circumstances this could include referral to the statutory Schools Adjudicator.
- All views will be considered before a decision is made.
