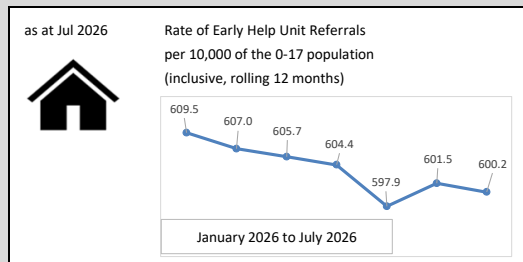

Commentary on Integrated Children's Services Indicators:

Children's Social Care

RED: The average caseload in the Children's Social Work Teams (CSWT) is 23.1 children, which is above the target caseload of no more than 18 children.

AMBER: The percentage of children becoming subject to a child protection plan for the second or subsequent time is 26.2% which is above the target range of 17.5% - 22.5%. This compares to average rates for England of 24.5%, Statistical Neighbours 24.3% and the South East 26.3% (2024/25). This measure includes all children subject to a subsequent Child Protection Plan regardless of the timescale between those plans. Current performance is impacted by repeat plans for several large sibling groups, including a sibling group of six children in April 2026.

AMBER: The percentage of Returner Interviews completed for those with Children's Social Work Involvement is 86.7%, which is close to the target of 90.0%. For those Returner Interviews that did take place, 86.9% took place within timescale (3 working days) which is above the 80.0% target.

AMBER: At 67.8% the percentage of children in care placed in KCC foster care, or in placements with relatives/friends, is below the Target of 70.0%.

AMBER: The percentage of care leavers in education, employment or training (of those KCC is in touch with) is 54.2% which is below the target of 60.0%. Those not in employment will include those not able to work due to illness, disability, pregnancy or parenting responsibilities and unaccompanied asylum seeking young people who remain without status and are not able to remain in education or gain employment when they reach the age of 18.

AMBER: The percentage of Children's Social Work Case File Audits graded good or outstanding is 82.8%, close to the target of 85.0%.

AMBER: The percentage of caseholding staff present in post was 83.0%, with 523.4 caseholding staff present in their post from a staffing establishment of 630.8 FTE. The target for this measure is 90.0%. The measure of staff present in post includes caseholding staff employed by KCC and Agency staff and excludes any vacancies or staff who are absent from their role, for example on maternity or long-term sick leave.

AMBER: The average caseload in the Children in Care (CIC) Teams is 17.3 children which is close to, but slightly above, the target of no more than 15 children/young people.

GREEN: The percentage re-referrals to Children's Social Work Services within 12 months of a previous referral was 21.5% , achieving the target of below 25.0%. This performance compares to the latest published England average of 22.6%, and averages of 20.5% for Kent's Statistical Neighbours and 28.4% for the South East (all comparative rates are for 2024/25).

GREEN: The percentage of Children in Care in same placement for the last two years (for those in care for two and a half years or more) is 70.0%, achieving the target of 70.0% or above. Kent's performance remains above the latest published average for England of 69.0%, for the South-East 68.0% and for Kent's Statistical Neighbours 70.8% (comparative data is for 2024/25).

GREEN: The average number of days between becoming a child in care and moving in with an adoptive family is 391.6 days which is below the nationally set guide of less than 426 days. This compares to the latest published England average of 475 days for 2024/25.

Intensive Early Help

AMBER: The percentage of referrals to an Early Help Unit where a previous episode ended within 12 months is 25.7%, which is just above the target of 25.0%.

AMBER: The average caseload within Early Help Units is 15.2 families which is within the amber tolerance set for this KPI.

GREEN: The percentage of Early Help Assessments completed within 30 working days is 93.4%, achieving the target of above 85.0%.

GREEN: The percentage of Early Help Unit cases that were audited and graded as good or outstanding is 91.2%, achieving above the 85.0% target.

Commentary on Education Indicators:

The majority of education indicators are annual. Commentary has only been provided for indicators where new data has been published since the last scorecard was issued where targets exist.

- RED:** The percentage of Year 12-13 age-group (16-17 year olds) not in education, employment or training (NEET) is a seasonally impacted indicator. In July 2026 it was 5.0% with 1,999 children NEET. For this reason, the Department for Education uses the rolled averages for December, January, and February. Published data for 2025/26 shows Kent to have 4.8% NEETs, which combined with the Not Known cohort (3.2%) the aggregate figure is 8.0%. There is insufficient capacity in Further Education and there has been a reduction in NEET provision. The Skills and Employability Service have adapted the way the NEET Support Service works with NEETs; using data to target resources on need; sharpening KCC's approach to NEET prevention.
- AMBER:** The percentage of pupils at EYFS achieving a Good Level of Development - FSM gap has widened and is 3 percentage points (pp) above the target of 21.0. Although the proportion of FSM eligible pupils achieving a Good Level of Development increased from 50.7% in 2025 to 54.7% in 2026, the attainment gap has widened because the outcomes for non FSM children improved at faster rate, rising from 73.5% to 78.7% over the same period.
- AMBER:** The percentage of pupils at KS2 achieving age-related expectations in Reading, writing & mathematics – FSM gap has widened and is 3pp above the target of 25. Although the proportion of FSM eligible pupils reaching the expected standard increased from 43% in 2025 to 44% in 2026, the attainment gap has widened because the outcomes for non FSM pupils improved at a faster rate, rising from 70% to 72% over the same period.
- AMBER:** The percentage of pupils with an Education, Health and Care Plan (EHCP) has increased from 5.8% in 2024/25 to 6.0% in 2025/26 and is 0.2pp above the target. This is equal to the England percentage and 1pp below the South- East.
- AMBER:** The percentages of pupils who are persistently absent from primary and secondary schools - all pupils based on 10% threshold are just above the targets but both have shown continuous improvement since 2022/23.
- AMBER:** The percentage of pupils who are severely absent from primary schools - all pupils based on 50% threshold at 1.2% is slightly higher than the target of 0.9%
- GREEN:** The rate of proven re-offending by CYP at 30.8 is better than the target of 32.9.
- GREEN:** The percentage of Children Missing Education (CME) cases, closed within 30 school days is 92.6% with 4,696 cases closed out of a total of 5,074
- GREEN:** The percentage of CYP registered to EHE who receive contact and additional information within 10 school days of them being brought to our attention at 96.7% remains above the target of 85%.
- GREEN:** The numbers of pupils permanently excluded from the primary phase, as a 12-month rolling average, at 25 equals the target of 25 or fewer.
- GREEN:** The numbers of pupils permanently excluded from the secondary phase – all Year 7 to Year 14 pupils is 63, sixteen pupils within the maximum target of 79.
