Low. The programme aims to be inclusive and will provide opportunities for people to connect and engage through creative activities. A range of artforms and wide geographical spread will encourage inclusivity.

Context – What we do now and what we are planning to do

We will coordinate an engagement programme to maximise opportunities for people visiting Kent or already living here and wanting to learn more about contemporary visual art. Through this, we aim to create a cultural legacy feeding into next year and the Open Golf.

Aims and Objectives

The Programme aims to encourage residents and visitors in Kent to engage with creative activity to broaden their understanding of contemporary visual art and to provide people with information about the history and heritage of the county to give them information which will help them make informed choices to encourage repeat visits and extended stays.

Beneficiaries

Kent and Kent residents and visitors.

Information and Data used to carry out your assessment

We used data collected annually through the Arts Investment Fund alongside consultation to develop our cultural strategy. This gives a good picture of the resources available in the sector to connect with protected characteristics.

We are also working with Visit Kent and Turner Contemporary which enables us to connect with a wider body of information.

Who have you involved and engaged with

We have engaged with the creative sector, wider partners and stakeholders through the Cultural Strategy which helps us develop an overview of our sector.

We used a range of mechanisms for communication including:

- Focus Group
- Online Survey
- Conference events
- Local conversations

Issues identified in the consultation included the desire to place a particular focus on children and young people in respect of them having a right to access cultural experiences as learning and wellbeing opportunities. In response to this, there was also a gap identified with a lack of work targeting older people and others who were potentially more isolated. There was a need identified to provide opportunities for migrant communities and, in the context of the freelance economy, a desire to consider fair pay.

Potential Impact

The programme will have a significant impact across the county by enabling the delivery of projects which have a positive impact across all protected characteristics. It alms to be inclusive and will provide opportunities for economic growth, community cohesion and wellbeing.

Adverse Impact and how can these adverse impacts be mitigated,

There will be no potentially adverse equality impacts across the protected characteristics.

We will work with Turner Contemporary and our cultural partners to monitor delivery and ensure this is the case. We will use the evaluation process to inform future thinking.
