MINUTES of a meeting of the Regulation Committee Mental Health Guardianship Sub-Committee held in the Medway Room, Sessions House, County Hall, Maidstone on Wednesday, 28 January 2015.

PRESENT: Mr M J Harrison (Chairman), Mrs M Elenor, Mrs S Howes, Mr S J G Koowaree and Mr C P Smith

IN ATTENDANCE: Mrs C Fenton (Learning Disability and Mental Health Officer), Ms C Brodie (Practice Support Manager) and Mr A Tait (Democratic Services Officer)

UNRESTRICTED ITEMS

1. Minutes - 29 January 2014 (To Note) (Item 3)

The Minutes of the meeting held on 30 January 2014 were noted, having been previously approved at the Regulation Committee meeting on 13 May 2014.

2. The Local Authority Guardianship Register (Item 4)

- (1) The Learning Disability and Mental Health Officer introduced her report by setting out that Section 23 (2) of the Mental Health Act enabled a discharge to be made in respect of a patient who was subject to guardianship by the responsible clinician, by the Local Social Services Authority or by the nearest relative. In conformity with Section 23 (4) of the Act, the function had been delegated to this Sub-Committee of the Regulation Committee which consisted of the Chairman of the Regulation Committee and Members of the Adult Social Care and Health Overview and Scrutiny Committee.
- (2) The Learning Disability and Mental Health Officer then said that the Sub-Committee also had the remit of auditing the effectiveness of receipt and scrutiny of documents. She moved on to describe the progress of the officer Working Party which had been set up for this purpose. It consisted of three officers from the Social Care, Health and Wellbeing Directorate and two co-opted independent members. The Working Party had met on five occasions over the previous year. One of its key functions (following amendments to its terms of reference in 2013/14) was to ensure that the named officers responsible for scrutinising applications for new orders and renewals had done so effectively. Any practical issues identified would be raised with the Approved Mental Health Professional Service in order that these could be addresed and that lessons learned could be shared.
- (3) The Learning Disability and Mental Health Officer briefly explained that, there were two ways in which guardianship application could be submitted to a Local Authority. This could happen either through an application for a new order under section 7 of the Mental Health Act or through a transfer under Section 19 from

Section 3 (detention in hospital) to Section 7 (guardianship). A decision on the latter had to be taken in the light of the identified "least restrictive option."

- (4) A decision to discharge a person from guardianship could be taken by a Mental Health Review Tribunal. As these Tribunals did not always inform the Local Authority when appeals were being heard, one of the Working Party's priorities during 2014 had been to ensure that all cases considered by a Tribunal were robustly accounted for and monitored. Work to achieve this had commenced.
- (5) The Learning Disability and Mental Health Officer then reported that two guardianship orders had been discharged since the Sub-Committee's last meeting in January 2014. During this period, two new guardianships had been accepted and there had been ten renewals (some of these had been for people whose orders had been renewed on two occasions on a six-monthly basis). Currently, there were eight people subject to guardianship in Kent (this figure having fluctuated between seven and nine since the cleansing of the register in 2013. The last figures presented to the Department of Health had been for the period 1 April 2013 to 31 March 2014. Nationally, there had been a decline of 4% of people under guardianship during this period.
- (6) The Chairman asked whether any of the people on the register were exservicemen. The Learning Disability and Mental Health Officer replied that none of them were. The current figure of 8 was made up from 5 people with Learning Difficulties associated with "abnormally aggressive or seriously irresponsible conduct", two with chronic mental health problems and one who had been transferred from a Section 3 (detention in hospital) order.
- (7) The Sub-Committee Members were invited to attend review meetings in appropriate numbers. The Learning Disability and Mental Health Officer agreed to advise the Democratic Services Officer when such meetings were taking place.
- (8) RESOLVED that the content of the report be noted together with the list of closed cases since January 2014 (set out in Appendix 1) and the current guardianship register (set out in Appendix 2).

Subject: The Local Authority's Guardianship Register

Summary: To report on the work of the Guardianship review panel during 2015.

A list of closed cases since January 2015 and the current

guardianship register are enclosed for information.

1. Introduction

- (1.1) The Kent County Council's Regulation Committee Mental Health Guardianship Panel was instituted in recognition of the duty of the responsible Social Services Authority to review guardianship orders and discharge them if appropriate, in compliance with amendments to the Mental Health Act 1983 that were introduced in 2007. Under Section 23(2) an order for discharge can be made in respect of a patient who is subject to guardianship by the responsible clinician, by the Local Social Services Authority or by the nearest relative of the patient. Section 23 (4) sets out the framework for exercising the powers conferred by this section and Kent County Council's Regulation Committee's arrangements conform to these provisions. The function is delegated to a sub-committee of at least 3 members. One is a member of the regulatory committee and the others, members of the Adult Social Services Policy Overview and Scrutiny Committee.
- (1.2) The amendments to the Mental Health Act in 2007 also introduced the requirement for Elected Members to "audit the effectiveness of receipt and scrutiny of documents". A working party of officers has been set up to carry out these duties. The acceptance of new guardianship orders or the renewal of existing guardianship orders is undertaken by the Director of Disabled Children, Adults Learning Disability and Mental Health on behalf of Kent County Council.
- (1.3) This report is to inform Elected Members of the current state of the authority's Guardianship Register and the work of the officers' working party during 2015. It contains the list of closed cases during 2015 at Appendix 1 and the current guardianship register at Appendix 2.

2. The Working Party

- (2.1) The working party is made up of three officers from the directorate of Social Care, Health and Wellbeing and two co-opted independent members who have had recent operational management experience within mental health. It is supported by a part time administrator and has met on four occasions since January 2015. Since it was established the working party has carried out a great deal of work to introduce robust processes and guidance to review and maintain high quality practice and accurate recording and reporting of guardianship orders. This has included reviewing the Guardianship Register and correcting any administrative errors.
- (2.2) During 2015/2016 the terms of reference of the working party have been reviewed and are in the process of being amended. The name of the group will change to The Guardianship Quality and Scrutiny Panel, in order to better reflect its role. The scrutiny process has been strengthened by the introduction of a role for the Quality Lead from the Approved Mental Health Professional (AMHP) service. This includes scrutiny of social circumstances reports and legal documents before they are submitted to Kent County Council, mentoring and training on any practice issues identified and membership of the Guardianship quality and scrutiny panel. A key role of the working group is to provide assurance that the named officers responsible for scrutinising applications for new orders and renewals have done so in a robust and informed manner.
- (2.3) Since January 2015 three guardianship orders have been discharged; seven guardianship orders have been accepted, both were transferred from Section 3 of the Mental Health Act (compulsory detention in hospital for treatment) into Guardianship under section 19 of the Mental Health Act. There are currently seven people subject to guardianship in Kent. Kent County Council is required to provide the Department of Health with data on those subject to guardianship on an annual basis. The last submission of data was on 30th April 2015 for the period 1st April 2014 to 31st March 2015. At this time it was reported that two new orders had been accepted during this period and three orders had been discharged. The next submission is due at the beginning of April 2016. This data can be seen at Appendix 3
- (2.4) Nationally there were 212 new Guardianship Orders during the reporting period 2014-2015, a decrease of 29 % from 2013-2014. As at 31st March 2015, 522 people in England were subject to a Guardianship order, a reduction of 108 (17 %) from the same point in 2014. This is also the tenth consecutive year of decline in continuing orders. The decline in Guardianship might be in part to the availability of other mental health legislation. The number of orders which came to an end during 2014-2015 reduced slightly (4%) from the previous year. The number of orders coming to an end during each year has now reduced for five consecutive years. The duration of the Guardianship orders which came to an end during 2014-2015 ranged from less than 3 months to over 10 years. The median duration of a Guardianship order in England is 12 months.

- (2.5) During the last 12 months the working party has reviewed and revised the Guardianship Policy to include guidance relating to transfers from Guardianship to section 3 (compulsory detention in hospital for treatment); the procedure to follow should a person subject to Guardianship go absent without leave; the transfer of a person from one local social service authority to another and the process for appeals to the Mental Health Review Tribunal.
- (2.6) Since the last annual report to the regulation committee on 29th January 2014 there has been no need for Members to be asked to adjudicate a disputed case, nor indeed have they been asked to discharge an order in accordance with their powers under Section 23(4) of the MHA 1983 (amended 2007).

3. Summary

(3.1) In summary there are robust processes in place for the review of guardianship orders, including renewals, that gives consideration to the least restrictive options available with the authority to make appropriate recommendations for discharge.

4. Recommendation

(4.1) The regulation committee is invited to note the content of this report together with the list of closed cases since January 2015 (Appendix 1), the Current Guardianship registers (Appendix 2) and the activity during 2015 Appendix 3).




