MINUTES of a meeting of the Standing Advisory Council on Religious Education (SACRE) held Online on Wednesday, 22 June 2022.

PRESENT: Mr S C Manion (Chairman), Mrs N Younosi (Vice-Chairman), Miss C Bostock, Mr A Brady, Mrs M Duncombe, Mrs J Grant, Ms F Hawkes, Mrs B Naden, Miss M Paddison, Mr J Paul, Miss E Pope, Mrs R Swansbury and Ms S Hamilton

IN ATTENDANCE: Mrs Penny Smith-Orr (RE Consultant), Mrs Michelle Lawson, Mrs K Goldsmith (Research Officer - Overview and Scrutiny) and Miss K Reynolds (Democratic Services Officer)

UNRESTRICTED ITEMS

43. Apologies for Absence/Substitutes (*Item 2*)

- 1. In the absence of the Chairman at the start of the meeting, Mrs Younosi chaired the meeting in her capacity as Vice-Chairman.
- 2. Apologies had been received from Ms Brownfield, Mrs Wigg, Miss Walters, Mrs Roddan, Mr Chambers and Ms Burke.

44. Minutes of the meeting held on 8 March 2022 (*Item 3*)

1. It was RESOLVED that the minutes of the meeting held on 8 March 2022 were correctly recorded and they be signed by the Chairman.

45. Membership

(Item 4)

- 1. The Vice Chair welcomed Mrs Michelle Lawson, the Headteacher of Wilmington Grammar School for Girls, as a guest to the meeting.
- 2. The Vice Chair welcomed the appointment of Ms S Hamilton, Deputy Cabinet Member for Education and Skills, onto SACRE.
- 3. Further to a Membership review conducted earlier in the year, Members were asked to agree the appointment of Miss Elizabeth (Liz) Pope as a co-opted member for another two-year term. There was unanimous agreement on the extension of Miss Pope's co-option in Group 3.
- 4. RESOLVED to agree the co-option extension and to note the membership of the Standing Advisory Council on Religious Education (SACRE).

46. SACRE Self Evaluation Tool - Sections 3, 4 and 5 (*Item 5*)

- 1. SACRE Members discussed Sections 3, 4 and 5 of the updated SACRE self-evaluation tool and agreed to the ratings of the key areas. The tool had been created to help SACREs in their role to advise the Local Authority (LA) in meeting the entitlement of pupils across the LA to engage in high quality Religious Education (RE) and Collective Worship (CW) and to support the LA to reflect on its practice.
- 2. The areas identified as needing improvement were to be included in the future development plan.
- RESOLVED to make a set of recommendations for SACRE to action.

47. Review of the Syllabus during 2022 (*Item 6*)

- 1. Members were reminded that for 2022, the approach had been amended to include a specific Executive Decision by the Cabinet Member for Education and Skills to better evidence the full process for developing and adopting a Locally Agreed Syllabus. In May 2022 the Agreed Syllabus Conference came to a unanimous agreement to recommend to the Cabinet Member for Education and Skills the licence renewal of the RE Today syllabus A+ for a further five years. The decision was due to be taken at the end of June 2022, and at that point schools could be informed.
- 2. Mrs Smith-Orr provided an update on the new units which had been confirmed as Key Stage 2.
- 3. RESOLVED to note the verbal update and to approve the minutes as a correct record and that they be signed by the chairman.

48. Developing Links with Teaching School Hubs (*Item 7*)

- 1. Miss Pope gave a verbal update on the work that had been undertaken to develop links with teaching school hubs. It was said that teaching school hubs were designed to provide high-quality professional development to teachers at all stages of their careers. It was highlighted that, given the size of Kent and the changes in the educational landscape, it was important for Kent SACRE to adjust to the bigger picture of Religious Education.
- Miss Pope told the Members that links had already been developed with other key stakeholders, including the Medway SACRE. Although she was still awaiting further contact from some parties, there was an overall positive response and willingness to work together moving forward.
- 3. In response to questions from Members, it was said that further work was required to raise awareness about RE training opportunities for early career teachers (ECT). Members agreed that RE training for ECTs would be a key area for inclusion in the 2022-23 development plan.

4. RESOLVED to note the verbal update.

49. The Wire Award

(Item 8)

- Members were asked to consider and make a judgement on the St Peter-in-Thanet CE Juniors and the Reculver Church of England Primary School Wire Award applications. Mrs Paddison endorsed the St Peter-in-Thanet CE Juniors application. Ms Burke endorsed the Reculver Church of England Primary School. Members commended the children's work
- 2. It was agreed that Mrs Paddison would present the certificate to St Peter-in-Thanet CE Juniors and Mrs Naden would present the certificate to Reculver Church of England Primary School.
- 3. RESOLVED to consider and make a judgement on the St Peter-in-Thanet CE Juniors and the Reculver Church of England Primary School Wire Award applications.

50. Films for Schools

(Item 9)

- 1. It was agreed that Mrs Swansbury would email Max Edwards about hosting the Films for Schools on the Kent YouTube page. It was suggested that the link to the films be provided with the new syllabus.
- 2. RESOLVED to note the verbal update.

51. NASACRE Conference May 23rd - Feedback (*Item 10*)

- Mrs Smith-Orr provided a verbal overview of the conference. Members were reminded that a summary of the conference was available on the NASACRE website. SACRE Members who had attended the conference virtually from Sessions House gave positive feedback on the arrangements.
- 2. Mrs Younosi provided a brief verbal summary of the workshops she had attended, including one on World Views as a methodology to teach RE. The Chairman said that the workshops encouraged SACREs to think more deeply about the issues around curriculum setting and achieving high quality RE.
- 3. With reference to the *Review of the Performance of Religious Education Report Card*, Mrs Smith-Orr highlighted the comment from a Year 10 pupil that "RE is the one time in school where you can talk, listen and try to make sense of people, events and beliefs in the world". Members were encouraged to critically consider the Report Card.
- 4. SACRE Members raised concern regarding the lack of primary school comments on the Report Card. It was said that, as primary teachers were differently qualified and required different training, there was a perceived secondary bias in the document.

5. RESOLVED to note the verbal update.

52. 20th October 2022 RE Teachers Training (*Item 11*)

- 1. Mrs Smith-Orr confirmed that RE teacher training would take place with RE Today on 20th October 2022 and that four trainers had been booked. The proposed venue would have the capacity to host the attendees across two different areas. Mrs Smith-Orr was in contact with the Education People regarding costings and it was confirmed that schools would be charged a small fee.
- In response to questions from Members it was said that there was an ongoing discussion with RE Today about the scope and focus of the training. Members agreed that further information was required about whether the new teaching units would be available by this date.
- 3. Members agreed that Mrs Smith-Orr could continue to make the necessary arrangements with RE Today on behalf of Kent SACRE.
- 4. RESOLVED to note the verbal update.

SACRE Meetings

The development plan is checked throughout the year. SACRE went through the self-evaluation of SACRE toolkit during the Spring meeting and the results will be used to inform the 2022-23 development plan. (Appendix B for results)

Applications for The WIRE Award are noted and judging of evidence is done at SACRE meetings if necessary.

The RE Consultant gives a verbal report at each meeting. The NASACRE AGM was attended by a number of members and discussed at the following meeting. Training of SACRE members takes place at the end of meetings. Other issues discussed were Interfaith activities, action on a Secondary teacher's hub meeting, the NASACRE workforce data2020, and a budget update is always provided by the Local Authority.

The Annual report is always presented to the Children, Young People and Education cabinet Committee.

Religious Education

This year there were discussions regarding the end of the 5-year license for the RE Today Agreed Syllabus which Kent schools' use. The revision of the syllabus was discussed at meetings and led to an Agreed Syllabus Conference on 12 May. The decision was to recommend to the Local Authority that we purchase a further 5-year license from RE Today along with some new updated units of work for the Primary and Secondary schools. The Local Authority agreed that this could be done, and that the payment could be covered by the Education department budget. The SACRE budget would pay for the trainers from RE Today and the launch of the revised syllabus.

There is various information on the Kelsi website for schools use and the email of the RE Consultant is there to enable teachers to contact her with any queries or worries. Many schools requested the digital version of the current syllabus and asked about the updating of the syllabus. Other enquiries were on methods of teaching and assessment and planning. The RE Adviser for Canterbury Diocese runs a network meeting and non-church school leads can join these. SACRE put on one big training event for schools each year, on 23rd September there was a virtual event with Professor Trevor Cooling discussing his views on 'Where now with World Views.'

During the year a film project continued, the lead teacher on the Teacher group in SACRE worked with pupils of faith to make short films useful for classroom learning. These are currently held in Canterbury and negotiations are ongoing to get them onto a platform that all teachers can access.

Having launched The WIRE award in 2019 schools which were in lockdown were mostly unable to complete. However, this is a standing item and during the year three schools achieved the award and were sent a certificate and congratulations from SACRE. Further schools have applied, and their evidence will be judged at the following SACRE meeting to the receipt of the evidence.

The WIRE award helps to a certain extent with monitoring. Once the new syllabus is launched there will need to be a process of monitoring schools to ensure they are using it successfully.

There have been no complaints regarding Religious Education teaching this year.

Collective Worship

The Guidance on Collective worship can be found on the Kelsi website alongside other guidance on different aspects of RE.

No determinations have been received by Kent SACRE, but the SACRE committee have had training on what to do if there ever was a determination application.

The members of various Interfaith groups in Kent, particularly the Maidstone Group are very proactive in going into schools and giving talks on their different faiths. These talks are gratefully accepted by schools.

SACRE Arrangements

The SACRE has the support of an RE Consultant at each meeting and advising teachers by email and organising one event annually. We also have the support of the Democratic services to do clerking for the meetings, The Education People service helps with arrangements for course for teachers.

The members of Kent SACRE are reasonably representative of the county of Kent new members are sought if there is a vacancy and members are asked for a letter of recommendation from their governing body. We are fortunate to have members from both the Rochester and Canterbury Boards of Education, this is useful for links with schools in Kent and for their insight into the state of RE and CW in the County. The budget holder of the SACRE budget is available and provides a termly budget update and the SACRE has up to £5000.00 per year to spend, this has been increased this year for the cost of the RE Today License which is charged for each of the 535 schools in Kent. All three meetings were virtual this year on Teams, some members found this difficult to access, it is planned that future meetings will be face to face and possibly hybrid. Meetings are held at Maidstone Council offices.
