#### LIST OF FORTHCOMING EXECUTIVE DECISIONS

Each week the list of Forthcoming Executive Decisions is updated where there are additions, deletions or amendments to be made. Although Kent County Council aims to include all known decisions, statute requires that all Key decisions must be publicised in this way.

A "Key Decision" is an Executive-side Decision which is likely to:

- (a) result in the council incurring expenditure which is, or the making of savings which are, significant having regard to the council's budget for the service or function to which the decision relates; or
- (b) be significant in terms of its effects on communities living or working in an area comprising two or more electoral divisions in the area of the local authority.

Key Decisions can only be taken by the Cabinet, the Leader or an individual Cabinet Member.

Decisions which should be regarded as Key Decisions because they are likely to have a significant effect either in financial terms or on the Council's services to the community include:

- (a) Decisions about expenditure or savings over £1,000,000 which are not provided for within the approved budget or Medium Term Financial Plan
- (b) Adoption of major new policies not included in the Policy Framework (Constitution Appendix 3) or significant changes to established policies
- (c) Decisions that involve significant service developments, significant service reductions, or significant changes in the way that services are delivered, whether County-wide or in a particular locality. For example, closure of a school, approval of a major project (such as a highway scheme) or programme of works, major changes in the eligibility criteria for provision of a service, major changes in the fees charged for a service, or proposals that would result in a service currently provided in-house being outsourced.
- (e) Decisions where the consequences are likely to result in compulsory redundancies or major changes in the terms and conditions of employment of a significant number of employees in any of the Council's functions.

Preparation of the list helps the Council to programme its work and ensures compliance with the 'Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) regulations 2012.

The list outlines the consultation that is proposed in respect of future decisions and who members of the public and the Council should contact to make comments on any particular item. Anyone is entitled to obtain copies of the documents that will be relied upon when a decision is taken, unless those documents are 'Exempt' within the meaning of the relevant sections of the Local Government Act 1972 (as amended).

These were conducted with offenders at HMP Elmley, Service users from East Kent, West Kent and Children and Young People's Services and Mental Health Service Users. The draft strategy was also presented at various partnership meetings including Community Safety Partnerships, Health and Wellbeing Boards (County and Local), CCG Clinical Leadership Teams and Joint Kent Chiefs.

#### 17/00064 Coroners Post Mortem Contract

The Coroners and Justice Act 2009 places a duty on Coroners to investigate deaths that are referred to them if they have reason to think that:

- The death was violent or unnatural:
- The cause of death is unknown; or
- The deceased died while in prison, police custody or another form of state detention e.g. where a Deprivation of Liberty Safeguard Order (DoLS) is in place

In some cases the Coroner will order a PM to establish the cause of death. In these cases, bodies are taken to a pre-designated mortuary. In 2016 of 1,973 deaths referred to the Senior Coroner for North West Kent, 750 required a PM (38% of

deaths referred).

On behalf of the Senior Coroner, KCC ensures there is adequate storage capacity for Coroner's bodies and that the Coroner has access to PM facilities. KCC does not have its own public mortuary facility and so like many other coroner areas across England and Wales it has always used local NHS hospitals which have the necessary facilities for this purpose as there are no private sector providers of PM facilities anywhere in England and Wales.

Currently, post mortems for the Mid Kent & Medway coroner area are carried out by Medway NHS Trust at Medway Maritime Hospital. The last contract expired on the 31<sup>st</sup> March 2017 and a new four year contract has been agreed for the period 1 April 2017 to 31 March 2021.

## 17/00051 - A274 Sutton Road, Maidstone, at its junction with Willington Street

The Maidstone Integrated Transport Package (ITP) aims to reduce congestion and ease traffic movements through the town.

Willington Street connects the A20 and A274 routes which are the two key corridors into Maidstone from the east and south east. The scope of this first

phase of the strategy is to improve the operation of the junction at the northern end of Willington Street with the A20 Ashford Road and the junction at the southern end of Willington Street with the A274 Sutton Road. At present, these signalised junctions at each end of Willington Street are heavily congested under peak traffic conditions.

In March 2016, a proposed scheme was discussed and welcomed at the Environment & Transport Cabinet Committee. However, further work on this scheme shows that it will not deliver the intended benefits and therefore a redesign was required. As the re-design is significantly different to the original scheme discussed, the revised scheme is being presented to Environment and Transport Cabinet Committee.

#### 16/00120 Sub National Transport Board for the South-East

KCC Membership of a shadow Sub- National Transport Body for the South East known as Transport for the South East (TfSE)

The Cities and Local Government Devolution Act makes provision for the establishment and constitution of Sub-National Transport Bodies (SNTBs) for any area in England (outside of Greater London. An SNTB can prepare a Transport Strategy for an area which would set out proposals for the promotion and encouragement of safe, sustainable, integrated, efficient and economic strategic transport facilities and services to and from the area of the SNTB.

The South East Seven (SE7) Councils (Kent, East Sussex, West Sussex, Hampshire and Surrey County Councils, and Brighton & Hove City Council and Medway Council) and the Local Enterprise Partnerships (LEPs) that represent the area have discussed the establishment of an SNTB for the South East, to be called Transport for the South East (TfSE). A TfSE on this geographic scale would fulfil the DfT's minimum geographic size requirements. Discussions will shortly commence with Portsmouth, Southampton and the Isle of Wight and the Solent LEP about joining TfSE.

The proposed TfSE would enables authorities to influence national and

regional infrastructure providers, helping to secure the infrastructure required to support continuing economic growth. A TfSE would see Government, South East Transport Authorities and/or Combined Authorities and LEPs working together with Highways England, Network Rail and port, airport and bus operators. TfSE would require strategic transport providers to take account of its priorities.

TfSE would provide a mechanism for the area to speak with a strong, common voice on transport infrastructure and provide a single platform for strategic transport and infrastructure issues, giving partners greater, and potentially direct, influence over decisions that are currently made elsewhere. Its key outcome will be the development of a single, strategic transport infrastructure framework which would align the investment programmes from key agencies, such as Highways England, Network Rail and the LEPs.

#### **Options**

- Do nothing and not engage in the development of the SNTB for the Southeast.
- Set up the SNTB for Kent and Medway, but this would not be supported by DfT
- Engage in the development of the Shadow SNTB Board and Transport Strategy for the Southeast

How the proposed decision meets the objectives of 'Increasing Opportunities, Improving Outcomes: Kent County Council's Strategic Statement (2015-2020)'

The cornerstone of TfSE is the Transport Strategy. It will build upon existing Local Transport Plans, including Kent's Local Transport Plan 4: Delivering Growth without Gridlock, currently out to consultation, and evidence already in place amongst the constituent Authorities, including the LEP's Strategic Economic Plans and growth and infrastructure frameworks/studies being undertaken by a number of upper-tier Authorities, including the Kent and Medway Growth and Infrastructure Framework. In this way, the decision would support the Council's second strategic outcome, "Communities benefit from economic growth by being in work, healthy and enjoying a good quality of life."

#### **Financial Implications**

It is estimated that appropriate support for developing the shadow SNTB and the overarching Transport Strategy would total £200,000 of which KCC's contribution is £20,000.

## 17/00052 - Revision to Term Dates for the School Years 2018/19 and 2019/20

Agreement will be sought from the Cabinet Member for Children, Young People and Education to revise the term dates for the school years 2018/19 and 2019/20.

In March 2016, the Cabinet Member for Education and Health Reform agreed to determine the school year term dates for 2017/18, 2018/19 and 2019/20. This followed a six week consultation with all schools and other key stakeholders such as governors (including parent groups), the diocesan bodies, trade unions and other neighbouring authorities. The general public was also encouraged to participate.

Feedback from this consultation included a request from a few teachers that Term 5 should end later in 2018/19 and 2019/20 to help regulate the length of each term.

Subsequently, the decision was taken to extend Term 5 in 2019 from 23 to 27 days with term ending on 31<sup>st</sup> May 2019 and Term 6 beginning on 10<sup>th</sup> June 2019. In 2020, Term 5 was extended from 25 to 28 days with term ending on 29<sup>th</sup> May 2010 and Term 6 beginning on 8<sup>th</sup> June 2020.

Since this decision, examination dates for secondary school pupils have been released by Exam Boards/Awarding Bodies. In 2019 and 2020, secondary education level exams have been scheduled to take place during the first week of June. It is therefore necessary to hold a consultation on the proposal to revise the date on which Term 5 ends in both 2019 and 2020.

The outcome of this consultation and revised term dates for 2018/19 and 2019/20 will be reported to the Children, Young People and Education Cabinet Committee taking place on Thursday 22<sup>nd</sup> June 2017.

- Firstly it helps deliver the "Kent Environment Strategy" by the provision of new environmentally friendly facilities (e.g. grey water) via the construction technique with the eventual adaptation of new work practices within the new depot.
- Secondly it builds relations with key business sectors across Kent as the supply chain involved in such a project provides work to businesses of all sizes.
- Thirdly by the better siting and provision of facilities for the new depot it ensures
  that the most robust and effective public protection arrangements are in place
  for road management including bad weather response.
